

AN ORDINANCE **97092**

**AUTHORIZING THE TRANSFER OF \$550.00 FROM THE DISTRICT 3 CONTINGENCY ACCOUNT FUND TO THE PARKS AND RECREATION DEPARTMENT FOR COSTS TO BE INCURRED IN ASSOCIATION WITH THE RENTAL OF A MOBILE STAGE FOR THE ST. LAWRENCE CATHOLIC CHURCH ANNUAL PARISH SPRING FESTIVAL TO BE HELD ON MAY 3, 2003; AS REQUESTED BY COUNCILWOMAN ANTONIETTE MOORHOUSE.**

**WHEREAS**, Councilwoman Antoniette Moorhouse, District 3, has requested City Council concurrence for the expenditure of \$550.00 from the Council District 3 Contingency Fund to be used for rental of the Parks and Recreation Department Mobile Stage for the annual St. Lawrence Catholic Church Parish Spring Festival to be held on May 3, 2003; and

**WHEREAS**, the City Council wishes to authorize the expenditure as requested by Councilwoman Antoniette Moorhouse, **NOW THEREFORE**;

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The request of Councilwoman Antoniette Moorhouse, District 3, for use of funds from the District 3 Contingency Budget Account in the total amount of \$550.00 for costs to be incurred by the Parks and Recreation Department for the rental of a mobile stage for the annual St. Lawrence Catholic Church Parish Spring Festival, to be held May 3, 2003, is hereby approved and authorized. A copy of Councilwoman Moorhouse's request is set out in Attachment I.

**SECTION 2.** The amount of \$550.00 is encumbered for payment in the District 3 Contingency Budget Account, Index Code 603506 entitled "District 3 Contingency Fund," and is authorized to be credited to the Parks and Recreation Department for the purpose set out above.

**SECTION 3.** The budget in the Parks and Recreation Department in Fund 11-000000 (General Fund), Index Code 015966 entitled "Parks Portable Stage Rental", is authorized to be increased in the amount of \$550.00.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific index codes and fund numbers as necessary to carry out the purpose of this Ordinance.
