

AN ORDINANCE **96750**

AUTHORIZING THE EXPENDITURE OF \$2,000.00 FROM VARIOUS CITY COUNCIL CONTINGENCY ACCOUNT FUNDS, PAYABLE TO THE SAN ANTONIO AREA HOMELESS ACTION COALITION, TO BE USED TO PROVIDE FOOD, CLOTHING AND OTHER PERSONAL ITEMS FOR THE HOMELESS DURING THE CHRISTMAS UNDER THE BRIDGE EVENT TO BE HELD DECEMBER 12-15, 2002; AS REQUESTED BY MAYOR EDWARD D. GARZA.

WHEREAS, Mayor has requested Council concurrence for the expenditure of \$1,000.00 from the Mayor’s Contingency Fund to assist the San Antonio Area Homeless Action Coalition, to be used to provide food, clothing and other personal items for the homeless during the Christmas Under the Bridge event to be held on December 12-15, 2002; and

WHEREAS, in addition, Council Member John H. Sanders, District 2 (\$500.00) and Bonnie Conner, District 8 (\$500.00), have requested Council concurrence for expenditures from their respective “District Contingency Accounts,” in the amounts indicated, similarly to assist the Christmas Under the Bridge event; and

WHEREAS, the City Council wishes to authorize the expenditure as requested by the Mayor, **NOW THEREFORE**;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The request of the Mayor, for reimbursement from the Contingency Fund in the amount of \$1,000.00 to the San Antonio Area Homeless Action Coalition, to be used to provide food, clothing and other personal items for the homeless during the Christmas Under the Bridge event to be held on December 12-15, 2002 is hereby approved and authorized. A copy of Mayor’s request is set out in Attachment I.

SECTION 2. The amount of \$2,000.00 is encumbered for payment from the following Contingency Budget Accounts and made payable to the San Antonio Area Homeless Action Coalition:





A copy of the "Agreement to Use Funds of the City of San Antonio" is attached hereto and appearing in substantially the same form as Attachment II.



The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific index codes and fund numbers as necessary to carry out the purpose of this Ordinance.
