

AN ORDINANCE **96604**

**AUTHORIZING THE ALLOCATION AND EXPENDITURE FROM HUMAN DEVELOPMENT SERVICES FUNDS AND THE EXECUTION OF AN AGREEMENT WITH SAN ANTONIO GATEWAY CORRIDOR INC. FOR THE DEVELOPMENT OF A COMPUTER ANIMATED PRESENTATION ILLUSTRATING VARIOUS MODIFICATIONS IN THE SAN ANTONIO ZOO AREA; AND PROVIDING FOR PAYMENT, AS REQUESTED BY COUNCILMAN CARROLL W. SCHUBERT, DISTRICT 9.**

**WHEREAS**, on August 29, 2002, Councilmember Carroll W. Schubert distributed a council six-signature memorandum requesting to place as a City Council agenda item the authorization to use Human Development Services Funds from District 9 in the amount of \$7,000.00, for support of the development of a computer animated CD-ROM illustrating various proposed modifications in the area surrounding the San Antonio Zoo; and

**WHEREAS**, the total cost for the development of the computer animated CD-ROM is estimated at \$25,000.00; and

**WHEREAS**, Councilmember Schubert also requested that at the time said item is considered, that other councilmembers consider contributing Human Development Services Funds for the development of this CD-ROM; and

**WHEREAS**, the public purpose for the expenditure is to benefit the welfare of the community through improved thoroughfares, a beautified landscape, increased family gatherings at the zoo and park and a gateway to the City for its residents and tourists; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The allocation and expenditure of Human Development Services Funds to San Antonio Gateway Corridor Inc. for the development of a computer animated CD-ROM illustrating various modifications in the San Antonio Zoo area is hereby approved in the following amounts:


**SECTION 2.** The Director of Finance is authorized to encumber funds in Fund 11-000 (General Fund) and made payable to the San Antonio Gateway Corridor, Inc. when actual amounts become final and available.


**SECTION 3.** The City Manager, or her designee, is authorized to execute an agreement with the San Antonio Gateway Corridor, Inc. in the amount of \$25,000.00 for the development of a computer animated CD-ROM illustrating various modifications in the San Antonio Zoo area. If an agreement, as first reviewed and approved by the City Attorney, is not signed by both parties within sixty (60) days from the effective date of this ordinance, it becomes null and void, and any further signed documents must be considered by the City Council.

**SECTION 4.** This ordinance shall be effective on and after the tenth (10<sup>th</sup>) day after passage hereof.
