

AN ORDINANCE **9 6 6 3 0**

AUTHORIZING THE EXPENDITURE OF \$1,000.00 FROM THE DISTRICT 4 CONTINGENCY ACCOUNT FUND, PAYABLE TO SOUTH SAN BOBCATS ASSOCIATION TO BE USED TO DEFRAY THE COST OF SUPPLYING THE TEAM WITH NEW JERSEYS AND FOOTBALL PANTS FOR THE POP WARNER FOOTBALL TEAM; AS REQUESTED BY COUNCILMAN ENRIQUE "KIKE" MARTIN, DISTRICT 4.

WHEREAS, Councilman Enrique "Kike" Martin, District 4, has requested Council concurrence for the expenditure of \$1,000.00 from the Council District 4 Contingency Fund to assist in defraying the cost of supplying the South San Bobcats Association Pop Warner football team with new jerseys and football pants; and

WHEREAS, a goal of the South San Bobcats Association Pop Warner football team is to promote community spirit and pride; and

WHEREAS, the City Council wishes to authorize the expenditure as requested by Councilman Enrique "Kike" Martin, **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The request of Councilman Enrique "Kike" Martin, District 4, for reimbursement from the District 4 Contingency Budget Account in the total amount of \$1,000.00 to help defray the cost of supplying the South San Bobcats Association Pop Warner football team with new jerseys and football pants, is hereby approved and authorized. A copy of Councilman Martin's request is set out in **Attachment I**.


SECTION 2. The City Manager, or her designee, is hereby authorized to execute an agreement with the South San Bobcats Association in the amount of \$1,000.00 for costs associated with supplying the South San Bobcats Association Pop Warner football team with new jerseys and football pants. A copy of the "Agreement to Use Funds of the City of San Antonio" is attached hereto and appears in substantially the same form as **Attachment II**.

SECTION 3. The amount of \$1,000.00 is encumbered for payment in the District 4 Contingency Budget Account, Index Code 603555 entitled "District 4 Contingency Fund," and is made payable to the South San Bobcats Association.


SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.
