

AN ORDINANCE **96653**

RATIFYING THE RENEWAL AND EXTENSION OF A CONTRACT WITH CAMBRIDGE INTEGRATED SERVICES GROUP, INC. TO PROVIDE THIRD PARTY CLAIMS ADMINISTRATION SERVICES FOR THE CITY'S SELF-INSURED LIABILITY AND WORKERS' COMPENSATION PROGRAMS, FOR A ONE YEAR PERIOD BEGINNING ON OCTOBER 1, 2002 THROUGH SEPTEMBER 30, 2003.

WHEREAS, the City of San Antonio ("City") employs a Third Party Claims Administrator to process, investigate, negotiate and make payments for claims in accordance with the Texas Tort Claims Act; and

WHEREAS, the City has had its Workers' Compensation program administered since 1974 and its Liability program administered since 1983, through various third party administrators; and

WHEREAS, the Third Party Claims Administrator provides a vital professional service to the City by processing approximately 1,900 Workers' Compensation claims and 1,400 Liability claims a year; and

WHEREAS, on July 27, 2000, Ordinance No. 92177 authorized the execution of a contract for Third Party Administration Services (the "Contract") with Cambridge Integrated Services Group, Inc.; and

WHEREAS, the Contract provided for a one year term, with the option to renew for four (4) additional successive one-year terms, subject to mutual agreement of the parties and approval by City Council; and

WHEREAS, the parties exercised the first renewal option through Ordinance No. 94620, passed and approved on September 27, 2001, and now wish to extend this Contract for an additional one year period, to begin on October 1, 2002 and continue through September 30, 2003; and

WHEREAS, the cost for this renewal period is \$1,011,750.00; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The second extension and renewal of the contract with Cambridge Integrated Services Group, Inc. to provide Third Party Claims Administration Services to the City for the period from October 1, 2002 through September 30, 2003 for a cost of \$1,011,750.00 is hereby ratified. A copy of the Renewal and Extension Agreement, in substantially final form, is attached hereto and incorporated herein as Exhibit "A".

SECTION 2. The amount of \$1,011,750.00 is to be appropriated in the Liability Fund (Fund 75-001) and Workers' Compensation Fund (75-003), Index Code 690529 for \$394,583.00 and


Index Code 690511 for \$617,167.00, to provide Third Party Claims Administration Services for a one-year term from October 1, 2002 through September 30, 2003.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.
