

AN ORDINANCE **96657**

AUTHORIZING THE ACCEPTANCE OF A GRANT AWARD IN THE AMOUNT OF \$20,000.00 FROM THE ANNIE E. CASEY FOUNDATION TO BE USED FOR THE ACQUISITION OF EQUIPMENT, TOOLS AND SUPPLIES NECESSARY TO IMPLEMENT CLEANUP PROJECTS REQUESTED THROUGH THE NEIGHBORHOOD SWEEP PROGRAM AND ESTABLISHING A COMMUNITY TOOL AS RECOMMENDED THROUGH THE COMMUNITY REVITALIZATION GROUP; AUTHORIZING THE EXECUTION OF ALL NECESSARY DOCUMENTATION IN CONNECTION THEREWITH; ESTABLISHING AND APPROPRIATING A PROGRAM BUDGET.

WHEREAS, the Annie E. Casey Foundation has awarded \$20,000.00 to the City of San Antonio Neighborhood Action Department for the acquisition of equipment tools and supplies necessary to implement cleanup projects requested through the Neighborhood Sweep Program and establish a community tool shed as recommended through the Community Revitalization Action Group; and

WHEREAS, the City Neighborhood Sweep Program provide two weeks of intensive City services which includes brush collection, code compliance, animal and vector control services, right-of-way cleanup, pot hole repair and street maintenance; and

WHEREAS, in addition to the City services provided through the Neighborhood Sweep Program, staff also is responsible for providing and coordinating special cleanup and beautification services to the elderly and to persons with disabilities; and

WHEREAS, the tools acquired through the grant funds will be available to community groups on a first come, first service basis; and

WHEREAS, the acceptance of this grant supports the program design adopted in the creation of the Neighborhood Sweep Program in 1997; and

WHEREAS, it is now the desire of the City Council to authorize the acceptance of the grant award and to authorize the execution of all necessary documentation in connection therewith;
NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee is authorized to accept a \$20,000.00 grant award from the Annie E. Casey Foundation for the period of October 1, 2002 to September 30, 2003, for the acquisition of equipment, tools and supplies necessary to implement cleanup projects requested through the Neighborhood Sweep Program and to establish a community tool shed as recommended through the Community Revitalization Action Group. The City Manager or her designee is further authorized to execute all necessary documentation in connection therewith.

SECTION 2. Fund No. 26-012229, entitled "NEIGHBORHOOD SWEEP PROGRAM 2002-2003," is hereby designated for use in accounting for the funds provided for said project.



SECTION 4. This ordinance shall be effective on and after the tenth (10th) day after passage hereof.


