

AN ORDINANCE

96829

**APPROPRIATING \$17,609.66 FROM 1999 GENERAL OBLIGATION DRAINAGE IMPROVEMENT BOND FUNDS TO THE CITY OF SAN ANTONIO PUBLIC WORKS DEPARTMENT TO PROVIDE CONSTRUCTION SERVICES FOR THE DIJON COURT DRAINAGE PROJECT, LOCATED IN COUNCIL DISTRICT 1.**

**WHEREAS**, the Dijon Court Drainage Project provided for the reconstruction of the Dijon Court Drainage; and

**WHEREAS**, the scope includes the installation of an inlet, laying 50 feet of 24 inch pipe, grading out a small interceptor ditch/channel, and reworking a portion of the concrete channel to mesh with the pipes and the interceptor ditch; and

**WHEREAS**, this work, which is scheduled to be completed by January 2003, will be performed by the City's Department of Public Works at a cost of \$17,609.66; and

**WHEREAS**, approval of this ordinance is a continuation of City policy to construct a 199 G. O. Drainage Improvements Bond funded Capital Improvement Projects; **NOW THEREFORE**,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The construction work to be provided by the City's Public Work Department for the Dijon Court Drainage Project is hereby authorized.

**SECTION 2.** The budget in Fund No. 45-962095, 1999 Drainage Improvements, Sold 2001, is revised by decreasing index code 695585, entitled "Unallocated Appropriations: Proceeds", by the amount of \$17,609.66.

**SECTION 3.** The amount of \$17,609.66 is appropriated in Fund No. 45-962012, 1999 Drainage Improvements, Sold 2001, in Index Code 759381, entitled "City Construction Services". The amount of \$17,609.66 is authorized to be encumbered and made payable to City forces for construction services in connection with the Dijon Court Drainage project.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by

the City Manager or the City Manager's designee, correct allocation to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.


**SECTION 5.** This ordinance shall take effect on the 22nd day of December 2002.
