

AN ORDINANCE      **9 6 8 4 4**

**AUTHORIZING 1999 GENERAL OBLIGATION DRAINAGE IMPROVEMENT BOND FUNDS IN THE AMOUNT OF \$2,100.00 BE MADE PAYABLE TO ECKMANN GROLL INC., FOR APPRAISAL SERVICES IN CONNECTION WITH THE OCTAVIA DRAINAGE #63, PHASE II PROJECT LOCATED IN COUNCIL DISTRICT 5, FOR A TOTAL SUM OF \$2,100.00; APPROPRIATING FUNDS AND PROVIDING FOR PAYMENT.**

**WHEREAS**, appraisal services were required for the Octavia Drainage #63, Phase II Project; and

**WHEREAS**, charges for such services are reasonable and necessary expenses relating to the above-mentioned projects; **NOW THEREFORE;**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The budget in fund 45-962095, 1999 Drainage Improvements, Sold 2001, is revised by decreasing Index Code 695585, entitled Unallocated Appropriations: Proceeds, by the amount of \$2,100.00.

**SECTION 2.** The amount of \$2,100.00 is appropriated in fund 45-962014, 1999 Drainage Improvements, Sold in 2001, in Index Code 938571, entitled Transfer to 45-969014 Octavia Drainage #63 Phase II. The amount of \$2,100.00 is authorized to be transferred from 45-962014 to 45-969014.

**SECTION 3.** The budget in fund 45-969000, 1999 Drainage Improvements, is adjusted by increasing Index Code 114777, entitled Transfer from 45-962014 (45-969014) Octavia Drainage #63.

**SECTION 4.** The amount of \$2,100.00 is appropriated in fund 45-969014, 1999 Drainage Improvements, in Index Code 758144, entitled Appraisal Services, and is

authorized to be encumbered and made payable to **Eckman Groll, Inc.**, for appraisal services in connection with the Octavia Drainage #63 Phase II Project.

**SECTION 5.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific index codes and fund numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 6.** This Ordinance shall be effective on the tenth day of passage hereof.




