

AN ORDINANCE

**AUTHORIZING PAYMENT OF ADDITIONAL FUNDS IN THE AMOUNT OF \$1,445.31 PAYABLE TO COUNTY OF BEXAR FOR FEE SIMPLE TITLE TO ONE PARCEL; AUTHORIZING THE AMOUNT OF \$11.00 PAYABLE TO COUNTY CLERK, FOR RECORDING FEES; FOR A TOTAL AMOUNT OF \$1,456.31 IN CONNECTION WITH THE MOCKERT STREET AREA (MOCKERT, FORREST, W. LAMBERT, KLINE, AND CASS) PROJECT; APPROPRIATING FUNDS AND PROVIDING FOR PAYMENT.**

**WHEREAS**, Ordinance No. 96645, passed and approved on October 31, 2002, appropriated the amount of \$928.00 to County of Bexar for fee simple title to a portion of one parcel in connection with the Mockert Street Area Project; and

**WHEREAS**, as part of the land transaction, the City staff has negotiated the terms of the transaction with the owner for the whole taking of this property and the City Council finds that the proposed terms are reasonable; and

**WHEREAS**, this ordinance amends Ordinance No. 96645 by appropriating the additional sum of \$1,456.31 to complete the purchase of this property; and

**WHEREAS**, funds are available to acquire the necessary parcel; **NOW, THEREFORE,**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The budget in Fund 45-972095, 1999 General Obligation Street Improvement Bonds, shall be revised by reducing Index Code 695577, entitled Unallocated Appropriations, in the amount of \$1,456.31.

**SECTION 2.** The budget in Fund 45-972026, 1999 General Obligation Street Improvement Bonds, shall be revised by increasing Index Code 920298, entitled Transfer to 45-979052, in the amount of \$1,456.31. The amount of \$1,456.31 is authorized to be transferred from Fund 45-972026 to Fund 45-979052.

**SECTION 3.** The budget in Fund 45-979000, 1999 Street Improvement Bonds, shall be revised by increasing Index Code 114355, entitled Transfer from 45-972026 (45-979052), in the amount of \$ 1,456.31.

**SECTION 4.** The amount of \$1,445.31 is appropriated in Fund 45-979052, 1999 Street Improvement Bonds, in Index Code 664235, entitled Title Fees, and is authorized to be encumbered and made payable to County Of Bexar, in connection with the Mockert Area Streets (Mockert, Forest, W. Lambert, Cass) Project.

**SECTION 5.** The amount of \$11.00 is appropriated in Fund 45-979052, 1999 Street Improvement Bonds, in Index Code 619684, entitled Recording Fees, and is authorized to be encumbered and made payable to County Of Bexar, in connection with Mockert Area Streets (Mockert, Forest, W. Lambert, Cass) Project.

**SECTION 6.** A copy of the respective instrument shall be submitted to the City Attorney for approval under Section 54, Charter of the City of San Antonio. If the instrument is approved by the City Attorney then the City of San Antonio accepts title to the respective parcels upon closing of this transaction.

**SECTION 7.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific Index Codes and funds numbers as necessary to carry out the purpose of this Ordinance.


**SECTION 8.** This Ordinance shall be effective on the tenth day after passage.


