

AN ORDINANCE **96851**

AUTHORIZING THE EXECUTION OF A LICENSE AGREEMENT WITH CHRISTUS SANTA ROSA HOSPITAL (CSRH) TO ALLOW FOR THE PERIODIC STATIONING OF CSRH'S MOBILE UNIT AT THE PARKING LOT OF PEARSALL PARK COMMUNITY CENTER LOCATED AT 5102 OLD PEARSALL ROAD FOR THE PURPOSE OF PROVIDING PRE-NATAL AND RELATED HEALTH SERVICES TO THE SURROUNDING COMMUNITIES, FOR THE PERIOD OF OCTOBER 1, 2002 THROUGH SEPTEMBER 30, 2003.

WHEREAS, the Department of Community Initiatives strives to decentralize the delivery of services to enhance client accessibility to a wide range of social and human development services; and

WHEREAS, the City of San Antonio, Department of Community Initiatives recently opened a new community center, Pearsall Park Community Center, in Council District 4 for the purpose of bringing additional essential human development services to the southwest area of the city; and

WHEREAS, the City of San Antonio, Department of Community Initiatives seeks to partner with other community-based agencies to offer essential social and human development services at its community centers; and

WHEREAS, the residents of the communities surrounding the Pearsall Park Community Center have specifically requested that health-related services be provided from that center; and

WHEREAS, Christus Santa Rosa Hospital (CSRH) has agreed to bring their mobile health unit to the Pearsall Park Community Center parking lot for the public purpose of providing pre-natal and related health services to the community, and it is in the best interests of the City of San Antonio to authorize a license permitting CSRH to station their mobile unit at the Pearsall Park Community Center parking lot; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee are authorized to execute a License Agreement with Christus Santa Rosa Hospital (CSRH) to allow for the periodic stationing of CSRH's mobile unit at the Pearsall Park Community Center located at 5102 Old Pearsall Road for the public purpose of providing pre-natal and related health services to the surrounding communities during the one-year period of October 1, 2002 through September 30, 2003. A copy of the License Agreement, in substantially final form, is attached hereto and incorporated herein for all purposes as Attachment I.

SECTION 2. This ordinance shall be effective on and after the tenth (10th) day after passage hereof.
