

AN ORDINANCE **96910**

AUTHORIZING THE TOTAL EXPENDITURE OF \$1,300.00 FROM THE VARIOUS CITY COUNCIL CONTINGENCY ACCOUNT FUNDS, PAYABLE TO THE BRACKENRIDGE HIGH SCHOOL 1962 STATE CHAMPS COMMITTEE, TO BE USED TO HELP DEFRAY COSTS ASSOCIATED WITH ITS 40TH ANNIVERSARY DANCE AND SCHOLARSHIP FUNDRAISER TO RAISE MONEY FOR SCHOLARSHIPS TO BE HELD ON SATURDAY, DECEMBER 21, 2002; AS REQUESTED BY COUNCILMAN ENRIQUE MARTIN.

WHEREAS, Councilman Enrique Martin, District 4, has requested Council concurrence for the expenditure of \$500.00 from the Council District 4 Contingency Fund to be used to help defray costs associated with its 40th Anniversary Dance and Scholarship Fundraiser to raise money for scholarships to be held on Saturday, December 21, 2002 incurred by the Brackenridge High School 1962 State Champs Committee; and

WHEREAS, in addition, Council Members Bobby Perez, District 1 (\$200.00), David A. Garcia, District 5 (\$350.00) and Julián Castro, District 7 (\$250.00) have requested Council concurrence for expenditures from their respective "District Contingency Accounts" in the amounts indicated, similarly to assist the Brackenridge High School 1962 State Champs Committee.

WHEREAS, the City Council wishes to authorize the expenditure as requested by Councilman Enrique Martin, **NOW THEREFORE**;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The request of Councilman Enrique Martin, District 4, for payment from the District 4 Contingency Budget Account in the total amount of \$500.00 to the Brackenridge High School 1962 State Champs Committee, for the purpose set out above is hereby approved and authorized. A copy of Councilman Martin's request is set out in Attachment I.

SECTION 2. The total amount of \$1,300.00 is encumbered for payment from the following Contingency Budget Accounts and is made payable to the Brackenridge High School 1962 State Champs Committee:

SECTION 3. The City Manager, or her designee, is hereby authorized to execute an agreement with the Brackenridge High School 1962 State Champs Committee in the amount of \$1,300.00 to help defray costs associated with the 40th Anniversary Dance and Scholarship Fundraiser. A copy of the "Agreement to Use Funds of the City of San Antonio" is attached hereto and appearing in substantially the same form as Attachment II.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific index codes and fund numbers as necessary to carry out the purpose of this Ordinance.

SECTION 5. This ordinance shall become effective on the tenth (10th) day after the passage hereof.
