

AN ORDINANCE **96964**

**AUTHORIZING THE TRANSFER OF \$822.67 FROM THE DISTRICT 1 CONTINGENCY ACCOUNT FUND, PAYABLE TO THE INTERNATIONAL CENTER, TO BE USED TO HELP DEFRAY COSTS ASSOCIATED WITH THE BANQUET HOSTED BY ITALIA RISTORANTE IN HONOR OF THE U.S. ARMY ALL STAR FOOTBALL TEAM MEMBERS AND THEIR FAMILIES TO BE HELD ON DECEMBER 31, 2002; AS REQUESTED BY COUNCILMAN BOBBY PEREZ.**

**WHEREAS**, Councilman Bobby Perez, District 1, has requested Council concurrence for the transfer of \$822.67 from the Council District 1 Contingency Fund to the International Center, to be used to help defray the cost associated with the banquet hosted by Italia Ristorante in honor of the U.S. Army All Star Football Team members and families to be held on December 31, 2002; and

**WHEREAS**, the City Council wishes to authorize the transfer as requested by Councilman Bobby Perez; **NOW THEREFORE**:

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The request of Councilman Bobby Perez, District 1, for the transfer of \$822.67 from the District 1 Contingency Account Fund to the International Center is hereby approved and authorized. A copy of Councilman Perez’s request is set out in Attachment I.


**SECTION 2.** The total amount of \$822.67 is authorized for transfer from District 1 Contingency Budget Account, Index Code 603415 entitled “District 1 Contingency Fund,” to the International Center, Activity Code 24-01-02; Rental of International Center Room (\$400.00), Activity Code 040121-001; Security Fee (\$30.00), Activity Code 040121-002; Custodial Fee (\$80.00), Activity Code 040121-003 and Catering Fee (\$312.67), Activity Code 040121-005.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager’s designee, correct allocations to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.


**SECTION 4.** This Ordinance shall become effective on the tenth (10<sup>th</sup>) day after the passage hereof.


