

AN ORDINANCE **9 6 9 1 7**

AUTHORIZING EXECUTION OF A CONTRACT WITH THE SAN ANTONIO PUBLIC LIBRARY FOUNDATION IN THE AMOUNT OF \$31,500.00 FOR THE BORN TO READ: NEWBORN READING INITIATIVE PROGRAM; AND AUTHORIZING THE ALLOCATION AND EXPENDITURE OF HUMAN DEVELOPMENT SERVICES FUNDS IN THE AMOUNTS OF \$10,000.00 FROM DISTRICT 10, \$5,000.00 FROM DISTRICT 1, \$1,000.00 FROM DISTRICT 3, \$1,000.00 FROM DISTRICT 4, \$1,000.00 FROM DISTRICT 5, \$3,000.00 FROM DISTRICT 9, \$5,000.00 FROM DISTRICT 8, \$2,000.00 FROM DISTRICT 7, \$2,500.00 FROM DISTRICT 6 AND \$1,000.00 FROM THE MAYOR'S CONTINGENCY ACCOUNT FUND IN CONNECTION THEREWITH; AS REQUESTED BY COUNCILMEMBER DAVID CARPENTER.

WHEREAS, the Fiscal Year (FY) 2002 Adopted Budget established the City Council Human Development Services Fund to support human development service-related purposes; and

WHEREAS, the San Antonio Public Library Foundation supports the Public Library and increases awareness and use of the Library through financial support and programmatic efforts, thereby enhancing the community's appreciation and utilization of the Library as a cultural and educational institution; and

WHEREAS, on December 12, 2002, Councilmember David Carpenter distributed a six-signature memorandum requesting to place as a City Council Agenda item the authorization to use Human Development Services Funds from District 10 in the amount of \$10,000.00 to support the Born to Read: Newborn Reading Initiative Program; and

WHEREAS, Councilman Carpenter also requested that other Councilmembers consider contributing Human Development Services Funds to support the San Antonio Public Library Foundation's Born to Read: Newborn Reading Initiative Program; and

WHEREAS, the Councilmembers desire to contribute human development and contingency funds totaling \$31,500.00 for said program; and

WHEREAS, the public purpose for this expenditure is to provide educational training for the community; and

WHEREAS, it is now the desire of the City Council to authorize the execution of a contract with the San Antonio Public Library Foundation in the amount of \$31,500.00 for the Born to Read: Newborn Reading Initiative Program; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or her designee, is authorized to execute a contract with the San Antonio Public Library Foundation in the amount of \$31,500.00 to support the Born to Read: Newborn Reading Initiative Program. A copy of said contract is attached hereto and incorporated herein for all purposes as Attachment I.

SECTION 2. The budget in Fund 11-000000 (General Fund) in the following index codes is authorized for reduction by \$31,500.00.

SECTION 4. This Ordinance shall be effective on and after the tenth (10th) day after passage hereof.




