

AN ORDINANCE

**ACCEPTING THE OFFER OF NORTHROP GRUMMAN INFORMATION TECHNOLOGY, INC., THROUGH THE STATE OF TEXAS DEPARTMENT OF INFORMATION RESOURCES NEGOTIATED AGREEMENT, TO PROVIDE THE CITY OF SAN ANTONIO INFORMATION TECHNOLOGY SERVICES DEPARTMENT WITH A SEAT MANAGEMENT/PERSONAL COMPUTER LEASING PROGRAM FOR AN ESTIMATED THREE YEAR COST OF \$1,250,000.00.**

**WHEREAS**, the City of San Antonio's Information Technology Services Department's (ITSD) has investigated the feasibility of implementing a Seat Management Contract, which would allow ITSD to lease personal computers and essential hardware, software, network capabilities and support services as opposed to purchasing; and

**WHEREAS**, ITSD's investigation concluded that utilizing the State of Texas Department of Information Resources Seat Management contract negotiated with Northrop Grumman Information Technology, Inc., would allow ITSD to replace obsolete personal computers in a timely fashion, enhance end user service support and achieve a desirable rate for technology refresh for both hardware and software in a cost-effective manner ; and

**WHEREAS**, this Seat Management contract meets the requirements under the terms of the State of Texas Cooperative Purchasing Agreement adopted by the City of San Antonio by Resolution No. 91-39-53 on September 12, 1991, **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The offer of Northrop Grumman Information Technology, Inc., under the State of Texas Department of Information Resources Cooperative Purchasing Agreement, in the amount of \$1,250,000.00 to provide the City of San Antonio Information Services Department with a three year Seat Management Contract is hereby accepted. A copy of the Texas Department of Information Resources Seat Management Contract (Northrop Grumman Information

Technology), the bid tabulation sheet and the Supplemental Agreement for Seat Management Support Services and Service Levels-City of San Antonio are attached hereto and incorporated herein as Attachment 1.


**SECTION 2.** Funding will not be expended by this ordinance. The approval of the contract specified in this ordinance is expressly contingent upon appropriation of funds.
