

AN ORDINANCE 97178

AUTHORIZING THE CITY MANAGER OR HER DESIGNEE TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT IN THE AMOUNT OF \$50,000.00 WITH THE SAN ANTONIO MOBILITY COALITION, INC. FOR ANNUAL MEMBERSHIP DUES FOR THE PERIOD FEBRUARY 1, 2003 THROUGH JANUARY 31, 2004; APPROPRIATING FUNDS; AND PROVIDING FOR PAYMENT

WHEREAS, the San Antonio Mobility Coalition, Inc. (SAMCO) is a nonprofit group, formed in 2001, and facilitates communication between public and private interests working to expedite the Metropolitan Planning Organization (MPO) 25-year Transportation Plan and lobby for funding for projects; and

WHEREAS, SAMCO's further purposes are to identify, publicize and advance the implementation of mobility solutions for San Antonio and Bexar County that will maintain and improve quality of life, economic growth, and business conditions in the area, and it is in the best interest of the City to participate with and assist SAMCO in promoting said purposes; and

WHEREAS, legislation was approved to allow the State of Texas to negotiate with organizations to construct and manage corridors and enable regional authorities to build toll roads; and

WHEREAS, funds in the amount of \$50,000.00 have been budgeted in the General Fund for the City of San Antonio's annual SAMCO membership dues for the period beginning February 1, 2003 through January 31, 2004; and

WHEREAS, approval of this Ordinance will be a continuation of City Council policy to cooperate in identifying and supporting the implementation of transportation mobility solutions for the San Antonio Metropolitan area; **NOW THEREFORE**;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee is hereby authorized to execute a Professional Services Contract, with San Antonio Mobility Coalition, Inc. (SAMCO), in substantially the same form as Attachment I attached hereto and incorporated herein for all purposes, which sets out the terms and conditions by which SAMCO will carry out its duties and provide benefits to San Antonio during the coming year in exchange for San Antonio's continued membership in SAMCO.

SECTION 2. Funds are authorized to be encumbered in the amount of \$50,000.00 in Fund 11-000000 (General Fund) in Index Code 430694 entitled "Transportation Alliance" and are made payable to the San Antonio Mobility Coalition, Inc. for annual membership dues for the period of February 1, 2003 through January 31, 2004.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific index codes and fund numbers as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance shall be effective on February 23, 2003.
