

AN ORDINANCE

AUTHORIZING THE ACCEPTANCE OF AN ADDITIONAL GRANT AWARD TOTALING \$591,984.00 FROM THE TEXAS DEPARTMENT OF HEALTH (TDH) TO SUPPORT THE SAN ANTONIO METROPOLITAN HEALTH DISTRICT'S ONGOING SEXUALLY TRANSMITTED DISEASE (STD) PROGRAM IN THE AMOUNT OF \$235,282.00 AND THE TUBERCULOSIS (TB) PREVENTION AND CONTROL PROGRAM IN THE AMOUNT OF \$356,702.00 FOR THE PERIOD JANUARY 1, 2003 THROUGH DECEMBER 31, 2003; AUTHORIZING EXECUTION OF THE CONTRACT CHANGE WITH THE TDH; REVISING THE PUBLIC HEALTH STATE SUPPORT PROJECT 2003/2004 - FEDERAL ACCOUNT ESTABLISHED IN ORDINANCE NO. 97154 PASSED AND APPROVED FEBRUARY 6, 2003; APPROVING A PERSONNEL COMPLEMENT; AND AUTHORIZING PAYMENTS FOR CONTRACTUAL SERVICES.

WHEREAS, the Texas Department of Health (TDH) provides annual financial assistance to the San Antonio Metropolitan Health District (SAMHD) to supplement the delivery of various comprehensive public health services to protect the health of all residents within the jurisdiction of the District; and

WHEREAS, Ordinance 97154, passed and approved on February 6, 2003, authorized the execution of Contract 7460020708 2004 between the SAMHD and the TDH, covering operation of the Public Health State Support Project 2003/2004 – Federal in the SAMHD; and

WHEREAS, the TDH has offered a contract change notice to the contract which will provide a grant award totaling \$591,984.00 to support the ongoing Sexually Transmitted Disease (STD) Program in the amount of \$235,282.00 and the Tuberculosis (TB) Prevention and Control Program in the amount of \$356,702.00 of the SAMHD for the period January 1, 2003 through December 31, 2003; and

WHEREAS, it is now necessary to authorize acceptance of the cash award and execution of the TDH contract change notice, revise the budget for the Public Health State Support Project 2003/2004 – Federal account, approve a personnel complement, authorize payments for contractual services, and approve payments for contractual services; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or her designee, is hereby authorized to accept and execute Contract Change Notice No. 02, Attachments 03 and 04, to Grant Contract 7460020708 2004, with the Texas Department of Health (TDH), providing a grant award totaling \$591,984.00 in support for the Sexually Transmitted Disease (STD) Program in the amount of \$235,282.00 and the Tuberculosis (TB) Prevention and Control Program in the amount of \$356,702.00 of the San Antonio Metropolitan Health District (SAMHD). A copy of Contract Change Notice No. 02 is set out in Attachment II and incorporated herein for all purposes.

SECTION 2. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific index codes and fund numbers as necessary to carry out the purpose of this ordinance.

SECTION 3. Fund No. 26-016058 entitled "Public Health State Support Project 2003/2004 – Federal" has been previously designated for use in accounting for the fiscal transactions of the programs within this project. This fund is authorized to be revised in accordance with Contract Change Notice No. 02.

SECTION 4. The sum of \$611,984.00 is hereby appropriated in the above-designated fund and the budget set out in Attachment I is approved and adopted for entry on the City books.

SECTION 5. Payments in an aggregate amount not to exceed \$11,400.00 are authorized for licensed contract physicians seeing patients suspected of having tuberculosis for the period January 1, 2003 through December 31, 2003. These payments will be made from Fund 26-016058, Activity 36-07-14, Index Code 794255 on a fee-for-service basis.

SECTION 6. Payments in an aggregate amount not to exceed \$26,000.00 are authorized for x-ray interpretation services for the period January 1, 2003 through December 31, 2003. These payments will be made from Fund 26-016058, Activity 36-07-14, Index Code 794255 on a fee-for-service basis.

SECTION 7. Consistent with the lease approved by Ordinance 96290 on September 5, 2002, rent payments in an aggregate amount not to exceed \$20,000.00 are authorized for the building at 814 McCullough in connection with the SAMHD's TB Prevention and Control Program for the period January 1, 2003 through December 31, 2003. These payments will be made from Fund 26-016058, Activity 36-07-14, Index Code 794172.

SECTION 8. The twenty (20) personnel positions set out in Attachment I and incorporated herein are authorized for the various activities shown thereon.


SECTION 9. Co-payments obtained from patients receiving services through the TB Clinic will be deposited in Fund No. 26-016058, Revenue Index Code 081562.

SECTION 10. Should the grant awarded be in an amount other than that budgeted for, or should the grant contain terms and conditions different than those currently existing, acceptance of the grant, budget and corresponding personnel complement will be subject to subsequent City Council ordinance.

SECTION 11. This ordinance shall be effective on and after the tenth day after passage hereof.
