

AN ORDINANCE **97089**

AUTHORIZING THE EXECUTION OF A CONTRACT WITH THE ALAMO AREA COUNCIL, BOY SCOUTS OF AMERICA IN THE AMOUNT OF \$60,753.00 FOR THE PROVISION OF EDUCATIONAL PROGRAMS FOR BOYS, GIRLS AND YOUNG ADULTS; AND AUTHORIZING THE ALLOCATION AND EXPENDITURE OF HUMAN DEVELOPMENT SERVICES FUNDS FROM DISTRICT 1 IN THE AMOUNT OF \$5,000.00, DISTRICT 3 IN THE AMOUNT OF \$1,253.00, DISTRICT 4 IN THE AMOUNT OF \$15,000.00, DISTRICT 6 IN THE AMOUNT OF \$15,000.00, DISTRICT 7 IN THE AMOUNT OF \$12,500.00, DISTRICT 8 IN THE AMOUNT OF \$2,000.00 AND DISTRICT 9 IN THE AMOUNT OF \$10,000.00, IN CONNECTION THEREWITH.

WHEREAS, the FY 2002 Adopted Budget established the City Council Human Development Services Funds to support human development service-related purposes; and

WHEREAS, the Alamo Area Council, Boy Scouts of America provides educational programs to boys, girls and young adults to build character, train in the responsibilities of participating citizenship, and develop personal fitness; and

WHEREAS, various Councilmembers desire to contribute human development services funds totaling \$60,753.00 to the Alamo Area Council, Boy Scouts of America for said purposes; and

WHEREAS, the public purpose for this expenditure is to support the community recreation and education of the youth of our community; and

WHEREAS, the Human Development Services Fund Guidelines, passed and approved by City Council on December 19, 2002, require that cumulative purchases to any one service provider that exceed \$25,000.00 must be approved by City Council; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or her designee, is hereby authorized to execute a contract with the Alamo Area Council, Boy Scouts of America in the amount of \$60,753.00 to support educational programs for boys, girls and young adults. A copy of said contract is attached hereto and incorporated herein for all purposes as Attachment I.

SECTION 2. The budget in Fund 11-000000 (General Fund) in the following index codes is authorized for reduction by \$60,753.00.
