

AN ORDINANCE **97240**

AUTHORIZING THE ACCEPTANCE OF A GRANT FROM THE TEXAS ASSOCIATION OF CHILD CARE RESOURCE AND REFERRAL AGENCIES (TACCRRA) IN THE AMOUNT OF \$65,813.00 TO ENHANCE THE OPERATION OF THE CITY OF SAN ANTONIO'S DEPARTMENT OF COMMUNITY INITIATIVES, CHILDREN'S RESOURCES DIVISION, KIDCARE RESOURCE AND REFERRAL NETWORK FOR THE PERIOD OF JANUARY 1, 2003 THROUGH AUGUST 31, 2003; AUTHORIZING THE EXECUTION OF A CONTRACT AMENDMENT IN CONNECTION THEREWITH; AND APPROVING A BUDGET AND PERSONNEL COMPLEMENT.

WHEREAS, the City of San Antonio through the Department of Community Initiatives, Children's Resources Division, Kid Care Resource and Referral Network contracts with the Texas Association of Child Care Resources and Referral Agencies (TACCRRA) to offer child care resource and referral services and education services in San Antonio, Bexar County, and thirty-three other counties in Texas; and

WHEREAS, the TACCRRA has informed the City of San Antonio of the availability of funds in the amount of \$65,813.00; and

WHEREAS, TACCRRA, in conjunction with the Texas Workforce Commission (TWC) has provided federally required assurances to the U.S. Department of Health and Human Services that Child Care Development Funds (CCDF) in the amount not to exceed \$65,813.00 will be used by the City to perform comprehensive data collection on childcare supply, demand, and gaps in childcare services, dissemination of consumer and educational information to families and childcare providers, and delivery of Resource and Referral service presentations in each of the three Workforce Development Areas; and

WHEREAS, it is now necessary to authorize the acceptance of said funds, authorize the execution of a contract amendment, and approve a budget and personnel complement; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO

Section 1. The City Manager, or her designee, is authorized to accept the grant award in the amount of \$65,813.00 from the Texas Association of Child Care Resource and Referral Agencies (TACCRRA) to enhance the operation of the City of San Antonio's Department of Community Initiatives, Children's Resources Division, Kid Care Resource and Referral Network for the period of January 1, 2003 through August 31, 2003. The City Manager, or her designee, is authorized to execute a contract amendment with the TACCRRA in connection therewith. A copy of the contract amendment is attached hereto and incorporated herein for all purposes as Attachment I.

Section 2. The budget for Project 26-039015 entitled “*Texas Association of Child Care Resource & Referral Agencies, Entitlement Period: 01/01/03-8/31/03*” which is attached hereto and incorporated herein for all purposes as Attachment II, and a Personnel Complement, attached hereto and incorporated herein for all purposes as Attachment III, are hereby adopted.

Section 3. This Ordinance shall be effective on and after the tenth (10th) day after passage hereof.
