

AN ORDINANCE **97242**

ACKNOWLEDGING THE ACCEPTANCE OF A GRANT AWARD IN THE AMOUNT OF \$2,500.00 FROM BANK ONE TO THE SAN ANTONIO HOUSING TRUST FOUNDATION, INC. AS FISCAL AGENT FOR THE CITY OF SAN ANTONIO FOR THE PURCHASE OF TEXT BOOKS TO BE USED BY THE NEIGHBORHOOD ACTION DEPARTMENT FOR ITS HOMEBUYERS' COUNSELING CLASSES DURING THE PERIOD OF OCTOBER 1, 2002 THROUGH SEPTEMBER 30, 2003.

WHEREAS, in an effort to partner with local lending institutions and assist them in their efforts to fulfill Community Revitalization Act (CRA) requirements, the City of San Antonio has engaged the San Antonio Housing Trust Foundation, Inc. through their annual Administrative Services Contract approved by City Council on October 31, 2002 (Ordinance No. 96656), to act as fiscal agent and accept donations on the City's behalf to support neighborhood & housing revitalization efforts; and

WHEREAS, the San Antonio Housing Trust Foundation, Inc. as fiscal agent for the City of San Antonio, has accepted a grant award in the amount of \$2,500.00 from Bank One for the purchase of text books to be used by the Neighborhood Action Department for its homebuyer's counseling classes during the period of October 1, 2002 through September 30, 2003; and

WHEREAS, the acceptance of the grant by the San Antonio Housing Trust Foundation, Inc. supports the Community Revitalization Action Group recommendations to provide education to support sustainable neighborhoods and create public/private partnerships; and

WHEREAS, it is now the desire of the City Council to acknowledge the acceptance of said grant by the San Antonio Housing Trust Foundation, Inc.; **NOW THEREFORE:**


BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Council of the City of San Antonio hereby acknowledges the acceptance of a grant award in the amount of \$2,500.00 from Bank One to the San Antonio Housing Trust Foundation, Inc., as fiscal agent for the City of San Antonio, for the purchase of text books to be used by the Neighborhood Action Department for its homebuyer counseling classes during the period of October 1, 2002 through September 30, 2003.
