

AN ORDINANCE **97334**

AUTHORIZING THE EXECUTION OF A CONTRACT WITH THE SUSAN G. KOMEN BREAST CANCER FOUNDATION SAN ANTONIO AFFILIATE IN THE AMOUNT OF \$3,600.00 FOR THE PURCHASE OF COMPUTER EQUIPMENT, COMPUTER SOFTWARE, EDUCATIONAL MATERIALS AND RELATED EXPENSES IN SUPPORT OF ITS OUTREACH ACTIVITIES; AND AUTHORIZING THE ALLOCATION AND EXPENDITURE OF HUMAN DEVELOPMENT SERVICES FUNDS IN THE AMOUNT OF \$1,000.00 FROM DISTRICT 6, \$500.00 FROM DISTRICT 1, \$500.00 FROM DISTRICT 4, \$200.00 FROM DISTRICT 5, \$500.00 FROM DISTRICT 7, \$200.00 FROM DISTRICT 8, \$500.00 FROM DISTRICT 9, AND \$200.00 FROM DISTRICT 10, IN CONNECTION THEREWITH; AS REQUESTED BY COUNCILMAN ENRIQUE M. BARRERA.

WHEREAS, the FY 2002 Adopted Budget established the City Council Human Development Services Funds to support human development service-related purposes; and

WHEREAS, the Susan G. Komen Breast Cancer Foundation San Antonio Affiliate offers educational and outreach initiatives aimed at improving breast cancer education, screening, and treatment for medically underserved women throughout the community; and

WHEREAS, on February 14, 2003, Councilmember Enrique Barrera circulated a six-signature memorandum requesting to place as a City Council Agenda item the authorization to use Human Development Services Funds from District 6 in the amount of \$1,000.00 for general outreach support for the Susan G. Komen Breast Cancer Foundation San Antonio Affiliate; and

WHEREAS, Councilmember Barrera also requested other Council members to consider contributing Human Development Services Funds for the support of the Susan G. Komen Breast Cancer Foundation San Antonio Affiliate: and

WHEREAS, various Councilmembers desire to contribute human development funds totaling \$3,600.00 for the support of outreach activities; and

WHEREAS, the public purpose for such an expenditure is to promote the health, safety and welfare of the Community; **NOW THEREFORE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, her designee, or the Director of the Department of Community Initiatives is authorized to execute a contract with the Susan G. Komen Breast Cancer Foundation San Antonio Affiliate in the amount of \$3,600.00 so that Susan G. Komen Breast Cancer Foundation San Antonio Affiliate may purchase computer equipment, computer software, educational materials and related expenses in support of its outreach activities. A copy of said contract is attached hereto and incorporated herein for all purposes as Attachment I.

SECTION 2. The budget in Fund 11-000000 (General Fund) in the following index codes in authorized for reduction by \$3,600.00.


