

AN ORDINANCE **97363**

**AUTHORIZING PAYMENT IN THE AMOUNT OF \$53,000.00 FROM 1994 G.O. DRAINAGE IMPROVEMENT BOND FUNDS TO SOUTHWESTERN BELL TELEPHONE CO. (SBC COMMUNICATIONS, INC.) FOR THE RELOCATION OF THEIR UNDERGROUND FACILITIES IN CONNECTION WITH THE W.W. WHITE FROM RIGSBY TO LORD PROJECT, LOCATED IN COUNCIL DISTRICT 2; APPROPRIATING FUNDS; AND PROVIDING FOR PAYMENT.**

**WHEREAS**, this Ordinance provides for payment in the amount of \$53,000.00 to Southwestern Bell Telephone Company (SBC) for relocation of underground facilities in connection with the W. W. White from Rigsby to Lord Project; and

**WHEREAS**, the W. W. White from Rigsby to Lord Project provides for drainage improvements along W. W. White from Rigsby to Lord, Rigsby from W. W. White to Salado Creek, and along Sea Breeze, Dell Crest, and Odessa; and

**WHEREAS**, due to the location with the City's proposed storm drainage box culvert crossing Rigsby Avenue near Comanche Creek, SBC underground facilities in the area require relocation; and

**WHEREAS**, the City has been requested by SBC to pay for the relocation of the underground facilities while reserving its right to seek reimbursement from SBC and is tracking the cost of each Project related to SBC relocation expenses; and

**WHEREAS**, approval of this Ordinance will be a continuation of City Council policy to complete previously approved 1994 G. O. Drainage Improvement Bond funded Capital Improvements Projects; **NOW THEREFORE**,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The budget in Fund 45-460095, 1994 Drainage Bonds – Sold in 2000, shall be revised by reducing Index Code 561258, entitled Unallocated Appropriations: Proceeds, in the amount of \$53,000.00.

**SECTION 2.** The amount of \$53,000.00 is appropriated in Fund 45-460003, 1994 Drainage Bonds - Sold 2000, in index code 920173, entitled Trf to 45-546007 WW White/Rigsby to Lord. The amount of \$53,000.00 is authorized to be transferred from 45-460003 to 45-546007.

**SECTION 3.** The budget in Fund 45-546000, 1985 Drainage & Flood Control, Sold 1994, is revised by increasing index code 129650, entitled Transfer from 45-460003 (45-546007) WW White, by \$53,000.00.


**SECTION 4.** The amount of \$53,000.00 is appropriated in fund 45-546007, 1985 Drainage & Flood Control, Sold 1994, in index code 756817, entitled Relocation-Underground SBC Facilities, and is authorized to be encumbered and made payable to Southwestern Bell Telephone Co. (SBC Communications, Inc.) for relocation of their facilities in connection with the W.W. White Phase I - Rigsby to Lord Project.


**SECTION 5.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific index codes and fund numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 6.** This Ordinance shall be effective on April 6, 2003.
