

AN ORDINANCE **97468**

**AUTHORIZING PAYMENT IN THE AMOUNT OF \$2,325.00 TO ECKMANN, GROLL INCORPORATED, FOR APPRAISAL SERVICES IN CONNECTION WITH THE HOLBROOK ROAD IMPROVEMENTS PHASE I PROJECT (\$700.00), LADDIE PLACE PROPERTIES PROJECT (\$800.00), LOOP 410 AT NACOGDOCHES DRAINAGE IMPROVEMENTS PROJECT (\$500.00), AND THE PLEASANTON ROAD – SOUTHCROSS TO MAYFIELD METROPOLITAN PLANNING ORGANIZATION PROJECT (\$325.00) APPROPRIATING FUNDS AND PROVIDING FOR PAYMENT.**

**WHEREAS**, appraisal services were required for the Holbrook Road Improvements Phase I Project, Laddie Place Properties Project, Loop 410 at Nacogdoches Drainage Improvements Project, and the Pleasanton Road – Southcross to Mayfield Metropolitan Planning Organization Project; and

**WHEREAS**, charges for such services are reasonable and necessary expenses relating to the above-mentioned projects; **NOW THEREFORE**;

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The total amount of \$2,325.00 is hereby authorized to be encumbered from the financial adjustments stated below and made payable to **ECKMANN GROLL INCORPORATED**, 115 East Travis Street, Suite 1515 for the Projects indicated.

- (a) The amount of \$700.00 is appropriated in Fund 45-467010, 1994 Drainage Bonds – Sold in 1998, in Index Code 926311, entitled Transfer to 45-546017 Holbrook Rd Improvements. The amount of \$700.00 is authorized to be transferred from Fund 45-467010 to Fund 45-546017.

The budget in fund 45-546000, 1985 Drainage & Flood Control, Sold 1994, shall be revised by increasing Index Code 127621, entitled Transfer From 45-467010(45-546017) Holbrook, by the amount of \$700.00.

The amount of \$700.00 is appropriated in Fund 45-546017, 1985 Drainage & Flood Control, Sold 1994, in Index Code 761726, entitled Appraisal Fees, in connection with the Holbrook Road Improvement Petroleum Dr. to Eisenhower project **Parcels 17458 and 17459.**

- (b) The amount of \$800.00 is appropriated in Fund 29-023001, Drainage Detention Project, in Index Code 937177, entitled Transfer to 40-006022. The amount of \$800.00 is authorized to be transferred from Fund 29-023001 to Fund 40-006022.

The budget in Fund 40-006022, Laddie Place Properties Project, shall be revised by increasing Index Code 100818, entitled Transfer From 29-023001 (40-006022) Laddie Place Properties, by the amount of \$800.00.

The amount of \$800.00 is appropriated in fund 40-006022, Laddie Place Properties Project, in Index Code 761999, entitled Appraisal Fees, in connection with the Laddie Place Properties project **Parcels 17469 and 17570**.

- (c) The budget in Fund 43-161095, 2001 Drainage Improvements, shall be revised by reducing Index Code 695718, entitled Unallocated Appropriations: Proceeds, by the amount of \$500.00.


The amount of \$500.00 is appropriated in Fund 43-161005, 2001 Drainage Improvements, in Index Code 762039, entitled Appraisal Fees, in connection with the Loop 410 at Nacogdoches Drainage Improvements project **Parcel 16869E**.

- (d) The amount of \$325.00 is appropriated in Fund 43-617014, 1996 Certificates of Obligation Street Improvement – MPO, in Index Code 577510, entitled Appraisal Fees, in connection with the Pleasanton Road – Southcross to Mayfield (MPO) project **Parcel 14729**.


