

AN ORDINANCE

AUTHORIZING PAYMENT IN THE AMOUNT OF \$15,523.03 TO DAVIDSON & TROILO, P.C., FOR LEGAL SERVICES IN CONNECTION WITH THE BABCOCK ROAD/LEON CREEK IMPROVEMENTS – HAUSMAN TO DEZAVALA PROJECT (\$3,458.30), BASSE ROAD AND SAN PEDRO INTERSECTION METROPOLITAN PLANNING ORGANIZATION PROJECT (\$36.00), BITTERS ROAD – WEST AVENUE AT HEIMER METROPOLITAN PLANNING ORGANIZATION PROJECT (\$9,299.97), PLEASANTON ROAD – SOUTHCROSS TO MAYFIELD METROPOLITAN PLANNING ORGANIZATION PROJECT (\$1,067.96), AND THE SALADO CREEK GREENWAY (HIKE & BIKE, PHASE I) PROJECT (\$1,660.80); REVISING THE BUDGET; APPROPRIATING FUNDS; AND PROVIDING FOR PAYMENT.

WHEREAS, legal services were required for the Babcock Road/Leon Creek Improvements Project, Basse Road and San Pedro Intersection (MPO) Project, Bitters Road – West Avenue to Heimer (MPO) Project, Pleasanton Road – Southcross to Mayfield (MPO) Project, and the Salado Creek Greenway (Hike & Bike, Phase I) Project; and

WHEREAS, charges for such services are reasonable and necessary expenses relating to the above-mentioned projects; **NOW THEREFORE**;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The total amount of \$15,523.03 is hereby authorized to be encumbered from the financial adjustments stated below and made payable to **DAVIDSON & TROILO, P.C., 7550 West IH-10, Suite 800, San Antonio, Texas, 78229-5815** for the Projects indicated.

- (a) The amount of \$3,458.30 is appropriated in Fund No. 45-746013, 1987 Drainage Sold 1994, in Index Code 632273, entitled “Legal Fees”, in connection with the Babcock Road Improvements – DeZavala to Hausman Rd. Project, **Parcels 14566, 14566A, and 14587.**
- (b) The amount of \$36.00 is appropriated in Fund No. 43-617011, 1996 Certificates of Obligation Street Improvement-MPO, in Index Code 460097, entitled “Legal Fees”, in connection with the Basse Road at San Pedro Intersection MPO Project **Parcel 8-14218.**
- (c) The amount of \$9,299.97 is appropriated in Fund No. 43-070004, Certificates of Obligation 2000A MPO, in Index Code 617365, entitled “Legal Fees”, in connection with the Bitters Road-West Avenue to Heimer (MPO) Project, **Parcels 16449 and 16451.**

- (d) The amount of \$1,067.96 is appropriated in Fund No. 43-617014, 1996 Certificates of Obligation Street Improvement – MPO, in Index Code 685180, entitled “Legal Fees”, in connection with the Pleasanton Road-Southcross To Mayfield Metropolitan Planning Organization Project, **Parcel 14729**.
- (e) The amount of \$1,660.80 is appropriated in Fund No. 45-959004, 1999 Flood Control with Park Improvements, in Index Code 631929, entitled “Legal Fees”, in connection with the Salado Creek Greenway (Hike & Bike, Phase I) Project , **Parcel 16510**.


