

AN ORDINANCE

AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION IN THE AMOUNT OF \$1,033,742.00 TO THE TEXAS DEPARTMENT OF HUMAN SERVICES FOR THE 2003 SUMMER FOOD SERVICE PROGRAM OPERATED BY THE DEPARTMENT OF PARKS AND RECREATION FROM JUNE 9, 2003 THROUGH AUGUST 1, 2003; AUTHORIZING THE ACCEPTANCE OF THE GRANT, IF AWARDED; APPROPRIATING FUNDS; APPROVING A BUDGET AND PERSONNEL COMPLEMENT; AUTHORIZING THE TRANSFER OF FUND BALANCES FROM THE 2002 SUMMER FOOD SERVICE PROGRAM BUDGET; AND AUTHORIZING THE ACCEPTANCE OF ADDITIONAL FOOD SUPPORT, IF AWARDED, DURING THE TERM OF THIS PROJECT.

WHEREAS, the City of San Antonio, through the Department of Parks and Recreation, has provided a Summer Food Service Program for the residents of San Antonio and Bexar County since 1969; and

WHEREAS, said program provides nutritional meals during the summer months to children age eighteen and below who would not otherwise have available the food assistance they receive during the school year through the National School Lunch and Breakfast Program; and

WHEREAS, the Department of Parks and Recreation operates this Summer Food Service Program in conjunction with the Summer Recreation Program; and

WHEREAS, the Texas Department of Human Services has advised the City that funds are available to provide a Summer Food Service Program for the period June 9, 2003 through August 1, 2003 and the City desires to apply for these funds; and

WHEREAS, it is now necessary to authorize the submission of an application for the Summer Food Service Program for 2003, establish a fund, approve a budget and personnel complement, authorize the payment of dumpster fees in connection with this project, and to authorize the acceptance of any additional food support funds received during the term of this grant; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

Section 1. The City Manager or her designee is hereby authorized to submit an application to the Texas Department of Human Services for \$1,033,742.00 in funding for the 2003 Summer Food Service Program operated by the Department of Parks and Recreation.

Section 2. The City Manager or her designee is hereby authorized to accept the 2003 Summer Food Service Program grant when awarded and to execute such documents as the granting agency shall require in connection with this grant.

Section 3. Summer Food Service Project 2003, Fund 26-017104 is hereby designated for use in accounting for the above project upon award of the TDHS grant.

Section 4. Subject to the award of the TDHS grant, the sum of \$1,033,742.00 is appropriated into Fund 26-017104 for the Summer Food Service Project 2003 and the budget set out in Attachment I is approved and adopted for entry on the City's books.

Section 5. When ascertained all funds balances remaining in Fund 26-017102, Summer Food Service Program 2002, are hereby authorized to be transferred into Fund 26-017104, Index Code 112219, Transfer From Fund 26-017102.


Section 6. The thirteen (13) Seasonal Employee personnel positions set out in Attachment II and incorporated herein, are authorized for the Summer Food Service Project 2003.


Section 7. Temporary loans from the General Fund to Fund 26-017104 pending collection of grant reimbursements from the TDHS under this grant award, are hereby authorized.


Section 8. The budget of the Summer Food Service Project 2003, Fund 26-017104 is hereby authorized to be revised to reflect any additional food support funds received from TDHS during the term of this project.

Section 9. This ordinance shall be effective on the tenth (10th) day after passage hereof.
