

AN ORDINANCE

AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH SARGEANT'S WHOLESALE BIOLOGICALS FOR THE PURCHASE OF ANIMAL CARCASSES FROM THE SAN ANTONIO METROPOLITAN HEALTH DISTRICT ANIMAL CARE SERVICES FACILITY TO BE USED FOR EDUCATIONAL PURPOSES AT A RATE OF \$2.50 PER SPECIMEN UNDER TWELVE POUNDS AND \$5.00 PER SPECIMEN TWELVE POUNDS AND OVER, FOR THE PERIOD APRIL 21, 2003 THROUGH APRIL 20, 2005.

WHEREAS, Ordinance Number 88221, passed and approved on August 6, 1998, authorized the execution of an Agreement between the City and Sargeant's Wholesale Biologicals for the purchase of animal carcasses from the San Antonio Metropolitan Health District Animal Care Services Facility for use in the preparation of anatomy specimens for educational and scientific use at a rate of \$3.00 per specimen during the period October 2, 1998 through September 30, 2000; and

WHEREAS, this ordinance also provided that the City and Contractor could renew this agreement at both parties option and subject to City Council approval; and

WHEREAS, Ordinance Number 92460, passed and approved on September 7, 2000, authorized the execution of an Agreement between the City and Sargeant's Wholesale Biologicals for the purchase of animal carcasses for the same use at a rate of \$3.25 per specimen during the period October 1, 2000 through September 30, 2002; and

WHEREAS, City and Sargeant's Wholesale Biologicals now desire to execute a new agreement at a rate of \$2.50 per specimen under twelve pounds and \$5.00 per specimen twelve pounds and over for the period April 21, 2003 through April 20, 2005; and

WHEREAS, it is now necessary to authorize the execution of this Agreement; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or her designee, is authorized to execute an Agreement with Sargeant's Wholesale Biologicals for the purchase of animal carcasses for educational purposes at a rate of \$2.50 per specimen under twelve pounds and \$5.00 per specimen twelve pounds and over from the San Antonio Metropolitan Health District Animal Care Services Facility for the period April 21, 2003 through April 20, 2005. A copy of this agreement in substantially correct form is set out in Attachment I and incorporated herein for all purposes.

SECTION 2. Payment received from Sargeant's Wholesale Biologicals from the sale of the animal carcasses will be deposited into the City General Fund, Revenue Account Index Number 01-014126, "Sale of Animal Carcasses".

SECTION 3. If an agreement, as first reviewed and approved by the City Attorney, is not signed by both parties within sixty (60) days from the effective date of this ordinance, it becomes null and void, and any further signed documents must be considered by the City Council.

SECTION 4. This ordinance shall be effective on and after the tenth (10th) day after passage hereof.
