

AN ORDINANCE      **97543**

**AMENDING A PROFESSIONAL SERVICES CONTRACT AND AUTHORIZING ADDITIONAL FUNDS IN AN AMOUNT NOT TO EXCEED \$11,550.00 FROM 1999 G.O. STREET IMPROVEMENT BOND FUNDS PAYABLE TO VICKREY & ASSOCIATES, INC. FOR ENGINEERING SERVICES IN CONNECTION WITH THE PRUE ROAD EXTENSION – PRUE TO HUEBNER PROJECT, LOCATED IN COUNCIL DISTRICT 8; APPROPRIATING FUNDS; AND PROVIDING FOR PAYMENT**

**WHEREAS**, a professional services contract with Vickrey & Associates, Inc. was authorized through Ordinance Number 92482 passed and approved on September 14, 2000 in connection with the Prue Road Extension-Prue to Huebner Project; and

**WHEREAS**, it is necessary to provide for additional compensation referencing said contract, in the amount of \$11,550.00, to Vickrey & Associates, Inc. for professional engineering service involving the preparation of rights of way acquisition documents; and

**WHEREAS**, approval of this Ordinance will be a continuation of City Council policy to complete previously approved 1999 General Obligation Street Improvement funded Capital Improvement projects; **NOW THEREFORE**,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The Professional Services Contract between the City of San Antonio and Vickrey & Associates, Inc. which was originally authorized by Ordinance Number 92482 dated September 14, 2000 is hereby amended in accordance herewith and the additional funds in an amount not to exceed \$11,550.00 for additional services in connection with the Prue Road Extension-Prue to Huebner Project is hereby authorized. A copy of the proposal is attached hereto and incorporated herein for all purposes as Attachment I.


**SECTION 2.** The amount of \$11,550.00 is appropriated in Fund 45-979044, 1999 General Obligation Street Bonds, in Index code 642132, entitled Engineering Contract, and is authorized to be encumbered and made payable to Vickrey &

Associates, Inc., in connection with the Prue Road Extension from Prue to Huebner Project.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific index codes and fund numbers as necessary to carry out the purpose of this Ordinance.


**SECTION 4.** This Ordinance shall become effective on the 11<sup>th</sup> day of May, 2003.
