

AN ORDINANCE **97624**

AUTHORIZING THE ACCEPTANCE OF \$37,710.00 IN CASH SUPPORT FROM THE TEXAS DEPARTMENT OF HEALTH (TDH) TO AUGMENT THE ONGOING LABORATORY BIOTERRORISM PREPAREDNESS PROGRAM OF THE SAN ANTONIO METROPOLITAN HEALTH DISTRICT; APPROVING THE EXECUTION OF A CHANGE TO THE CONTRACT WITH THE TDH; REVISING THE BUDGET FOR THE PUBLIC HEALTH STATE SUPPORT PROJECT 2002-2003 – FEDERAL; AND AUTHORIZING PAYMENTS FOR CONTRACTUAL SERVICES.

WHEREAS, the Texas Department of Health (TDH) provides annual financial assistance to the San Antonio Metropolitan Health District (SAMHD) to supplement the delivery of comprehensive public health services to protect the health of all residents within the jurisdiction of the District; and

WHEREAS, Ordinance 94306, passed and approved on August 9, 2001 authorized the execution of Contract 7460020708 2003 between the City of San Antonio and the TDH to cover the operation of the Public Health State Support Project 2002-2003 in the SAMHD; and

WHEREAS, Ordinance 96430, passed and approved on September 26, 2002 authorized the execution of TDH Contract Change Notice Number 08 and acceptance of \$518,394.00 for the Laboratory Bioterrorism Preparedness Program of the SAMHD; and

WHEREAS, the TDH has now offered through Contract Change Notice Number 15 cash support of \$37,710.00 to fund additional laboratory computer equipment purchases for the Laboratory Bioterrorism Preparedness Program; and

WHEREAS, it is now necessary to accept the additional cash support, authorize execution of the contract change notice, revise the budget of the Public Health State Support Project 2002-2003 - Federal account, and authorize payments for contractual services; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or her designee, is hereby authorized to accept Contract Change Notice Number 15, comprised of Attachment Number 16B to Grant Contract 7460020708 2003, with the Texas Department of Health (TDH), providing \$37,710.00 in cash to augment support for the ongoing Laboratory Bioterrorism Preparedness Program in the San Antonio Metropolitan Health District. The City Manager, or her designee, is hereby authorized to execute such documents as the agency may require in awarding this grant. A copy of Contract Change Notice Number 15 is set out in Attachment II and incorporated herein for all purposes.

SECTION 2. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific index codes and fund numbers as necessary to carry out the purpose of this ordinance.

SECTION 3. The account entitled "Public Health State Support Project 2002-2003 - Federal, Fund No. 26-016052, has previously been designated for use in the accounting for this project. This fund is authorized to be revised in accordance with TDH Contract Change Notice Number 15.

SECTION 4. The sum of \$37,710.00 is hereby appropriated in the above-designated fund and the budget set out in Attachment I is approved and adopted for entry on the City books.


SECTION 5. Payments in an aggregate amount not to exceed \$45,010.00 are hereby authorized for laboratory computer equipment purchases during the period September 1, 2002 through August 31, 2003. These payments will be made from Fund 26-016052, Activity 36-10-05, Index Code 743914.


SECTION 6. Should the grant awarded be in an amount other than that budgeted for, or should the grant contain terms and conditions different than those currently existing, acceptance of the grant, budget and corresponding personnel complement will be subject to subsequent City Council ordinance.

SECTION 7. This ordinance shall be effective on and after the tenth day after passage hereof.
