

AN ORDINANCE **97630**

AUTHORIZING THE EXECUTION OF AN AMENDMENT TO A DELEGATE AGENCY CONTRACT WITH THE UNIVERSITY OF TEXAS AT SAN ANTONIO INCREASING THE CONTRACT BY \$31,000.00, FOR A TOTAL CONTRACT AMOUNT OF \$71,095.00, IN CONNECTION WITH THE PRE-FRESHMAN ENGINEERING PROGRAM; AND AUTHORIZING THE ALLOCATION AND EXPENDITURE OF HUMAN DEVELOPMENT SERVICES FUNDS IN THE AMOUNT OF \$10,000.00 FROM DISTRICT 1, \$1,000.00 FROM DISTRICT 5 AND \$20,000.00 FROM DISTRICT 7 IN CONNECTION THEREWITH.

**WHEREAS**, the City of San Antonio presently has a delegate agency contract with the University of Texas at San Antonio in the amount of \$40,095.00 to operate the Pre-freshman Engineering Program; and

**WHEREAS**, the Pre-freshman Engineering Program is an academically intense, mathematics-based summer program for middle school and high school students; and

**WHEREAS**, pursuant to Ordinance No. 96958, passed and approved on December 19, 2002, the City Council adopted human development guidelines that authorized the expenditure of human development services funds for education and training expenditures for the youth in the community; and

**WHEREAS**, Councilmembers Perez, Herrera, and Castro have expressed their intent to provide human development services funds to the Pre-freshman Engineering Program in the total amount of \$31,000.00; and

**WHEREAS**, it is now the desire of the City Council to authorize the amendment of the City's delegate agency contract with the University of Texas at San Antonio to increase the amount of the contract by \$31,000.00 for the provision of additional services in connection with the Prefreshman Engineering Program; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager or her designee is authorized to execute an amendment to the delegate agency contract with the University of Texas at San Antonio ("UTSA") by increasing the amount of the contract by \$31,000.00 for a total contract amount of \$71,095.00 in connection with the Pre-freshman Engineering Program. A copy of the contract amendment is attached hereto and incorporated herein for all purposes as Attachment I.

**SECTION 2.** The budget in Fund 11-000000 (General Fund) in the following index codes is authorized for reduction by \$31,000.00.




