

AN ORDINANCE

97668

AUTHORIZING ALLOCATION AND EXPENDITURE OF HUMAN DEVELOPMENT SERVICES FUNDS IN THE AMOUNT OF \$1,000.00 FROM DISTRICT 5, \$1,000.00 FROM DISTRICT 6, \$2,500.00 FROM DISTRICT 7, \$2,500.00 FROM DISTRICT 8, \$1,000.00 FROM DISTRICT 9 AND \$1,000.00 FROM DISTRICT 10, FOR A TOTAL AMOUNT OF \$9,000.00, IN SUPPORT OF THE PUBLIC LIBRARY SUMMER READING PROGRAM; AS REQUESTED BY COUNCILMAN JULIAN CASTRO, DISTRICT 7.

WHEREAS, the FY 2002 Adopted Budget established the City Council Human Development Services Funds to support human development service-related purposes; and

WHEREAS, the Library Department operates the Summer Reading Program from June 2 through July 26 to encourage summer reading in youth; and

WHEREAS, on May 8, 2003, Councilmember Julian Castro circulated a six-signature memorandum requesting to place as a City Council Agenda item the authorization to use human development services funds from District 7 in the amount of \$2500.00 for the Library Departments Summer Reading Program; and

WHEREAS, Councilmember Castro also requested that other City Council members consider contributing human development services funds to the Library Departments Summer Reading Program; and

WHEREAS, the public purpose for this expenditure is to educate the youth in our community; and

WHEREAS, the Councilmembers desire to contribute human development services funds totaling \$9,000.00 for the general operating support for the Library Department's Summer Reading Program; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The allocation and expenditure of human development services funds in the amount of \$2,500.00 from District 7, \$1,000.00 from District 5, \$1,000.00 from District 6, \$2,500.00 from District 8, \$1,000.00 from District 9, and \$1,000.00 from District 10 for support of the Library Department's Summer Reading Program is hereby authorized.

SECTION 2. The budget in Fund 1 1-000000 (General Fund) in the index codes listed below are authorized to be reduced by \$9,000.00 in support of the Library Department's Summer Reading Program, as requested by Councilmember Julian Castro.

SECTION 3. Funds in the amount of \$9,000.00 are authorized for appropriation in Fund 62-014009 (Expendable Trust Funds-S.A. Library Foundation: Gifts & Memorial Fund) in index code 046342 entitled "Contributions" in support of the Summer Reading Program.

SECTION 4. The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this ordinance.


SECTION 5. This ordinance shall be effective on and after the tenth (10th) day after passage hereof.
