

AN ORDINANCE **97565**

RESCHEDULING THE CITY COUNCIL MEETINGS AND SUBCOMMITTEE MEETINGS OF JULY 3RD, 10TH, 17TH, 24TH, AND 31ST; AND THE CITY COUNCIL MEETINGS OF NOVEMBER 20TH AND 27TH, DECEMBER 11TH AND 25TH, 2003; AND JANUARY 1ST, 2004.

WHEREAS, the City Council members and City staff traditionally participate in the budget process; and

WHEREAS, it is necessary to reschedule the July meetings in order to allow the City Council members to have additional time to engage in budget work preparation; and

WHEREAS, the City Council meetings scheduled for July are to be rescheduled, and therefore the subcommittee meetings scheduled for July also need to be rescheduled; and

WHEREAS, various City Council members plan to attend the upcoming conferences of the Texas Municipal League of Cities and National League of Cities, which are scheduled to be held in November and December; and

WHEREAS, Thanksgiving Day is an official City holiday, and the City Council meeting which would normally be held on this day is traditionally rescheduled; and

WHEREAS, the City Council meetings which normally fall during the weeks of Christmas and New Year's Day are also traditionally rescheduled; and

WHEREAS, for all the aforementioned reasons, the City Council of the City of San Antonio wishes to reschedule certain City Council meetings and Council Subcommittee Meetings, **NOW THEREFORE**;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:
