

AN ORDINANCE **97725**

AUTHORIZING THE ALLOCATION AND EXPENDITURE OF HUMAN DEVELOPMENT SERVICES FUNDS IN THE AMOUNT OF \$500.00 FROM DISTRICT 1, \$500.00 FROM DISTRICT 3, \$500.00 FROM DISTRICT 5, \$500 FROM DISTRICT 6, \$500.00 FROM DISTRICT 7, \$500.00 FROM DISTRICT 8, \$500.00 FROM DISTRICT 9 AND \$500.00 FROM DISTRICT 10 IN SUPPORT OF THE BARSHOP JEWISH COMMUNITY CENTER TO SUPPORT THE SENIOR GAMES OF SAN ANTONIO 2003; AS REQUESTED BY COUNCILWOMAN BONNIE CONNER.

WHEREAS, the FY 2002 Adopted Budget established the City Council Human Development Services Funds to support human development service-related purposes; and

WHEREAS, Senior Games of San Antonio 2003 promotes the mental and physical wellness of adults over age **fifty**; and

WHEREAS, on May 12, 2003, Councilmember Bonnie J. Conner circulated a six-signature memorandum requesting to place as a City Council Agenda item the authorization to use human development services funds from District **8** in the amount of \$500.00 for the Barshop Jewish Community Center of San Antonio in support of the Senior Games of San Antonio 2003; and

WHEREAS, Councilmember Connor also requested other Councilmembers to consider contributing human development services funds to the Barshop Jewish Community Center of San Antonio in support of the Senior Games **of** San Antonio 2003; and

WHEREAS, various Councilmembers desire to contribute human development services funds totalling \$4,000.00 for the support of said event; and

WHEREAS, the public purpose for such an expenditure is to support community recreation for the elderly; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, her designee or the Director of Community Initiatives or his designee, is authorized to execute a contract with the Barshop Jewish Community Center of San Antonio in the amount of \$4,000.00 in support of the Senior Games of San Antonio 2003. A copy of said contract **is** attached hereto and incorporated herein for all purposes as **Attachment I.**

SECTION 2. Funds in the amount of \$4,000.00 are authorized to be encumbered in Fund 11-000000 (General Fund) in the Index Codes specified below and are made payable to the Barshop Jewish Community Center of San Antonio.


