

AN ORDINANCE      **9 7 8 2 2**

ACKNOWLEDGING A UNILATERAL MODIFICATION TO THE YOUTH OPPORTUNITY (YO) GRANT CONTRACT WITH ALAMO WORKFORCE DEVELOPMENT, INC., WHICH AWARDS FUNDS IN AN AMOUNT UP TO \$4,731,656.00 AND EXTENDS THE CONTRACT TERM FOR THE PERIOD FROM JULY 1, 2003 TO JUNE 30, 2004; ADOPTING A BUDGET; AND APPROVING A PERSONNEL COMPLEMENT IN CONNECTION THEREWITH.

**WHEREAS**, the City of San Antonio has contracted with the Alamo Workforce Development, Inc. (AWD) to provide services under the Youth Opportunity (YO) Grant program of the Department of Labor; and

**WHEREAS**, pursuant to Section 5.7.2. of said contract, approved by Ordinance No. 91983 passed on June 15, 2000, AWD may unilaterally amend the contract for the purpose of establishing or clarifying local policy, awarding new or additional funds, reducing or adjusting funding allocation, or when AWD determines it is in the best interest of the Alamo Workforce Development Area; and

**WHEREAS**, the AWD has submitted a Unilateral Modification to the YO contract awarding funds in an amount up to \$4,731,656.00 for the period of July 1, 2003 to June 30, 2004; and

**WHEREAS**, it is now necessary to acknowledge said modification; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** A Unilateral Modification to the Alamo Workforce Development, Inc. (AWD) contract for the Youth Opportunity (YO) Grant Program, which awards up to \$4,731,656.00 to the City and extends the term of the City's contract with AWD for the YO Grant Program to June 30, 2004, is hereby acknowledged. A copy of the award letter is attached hereto and incorporated herein for all purposes as Attachment I.

**SECTION 2.** The City Manager or her designee are authorized to accept a grant award in an amount up to \$4,731,656.00 from the AWD for the YO Grant Program for the period of July 1, 2003 to June 30, 2004.


**SECTION 3.** Fund No. 26-029065, entitled "San Antonio Youth Opportunity Grant – Year 4" is hereby designated for use in accounting for the above grant, and an amount up to \$4,731,656.00 is hereby appropriated in said fund as set out in the detailed budget attached hereto and incorporated herein for all purposes as Attachment II.


**SECTION 4.** The personnel complement, attached hereto and incorporated herein for all purposes as Attachment III, is hereby approved.



The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this ordinance.

**SECTION 6.** This ordinance shall be effective on and after the tenth (10<sup>th</sup>) day after passage hereof.
