

AN ORDINANCE **97823**

ACKNOWLEDGING AND ACCEPTING A CONTRACT MODIFICATION FROM ALAMO WORKFORCE DEVELOPMENT, INC. (AWD) IN CONNECTION WITH THE CONTINUED OPERATION OF THE ALAMO CHILD CARE DELIVERY SYSTEM (CCDS) PROGRAM; AUTHORIZING THE ACCEPTANCE OF ADDITIONAL FUNDS IN THE AMOUNT OF \$931,000.00 FROM AWD FOR THE PROVISION OF CHILD CARE SERVICES IN CONNECTION THEREWITH; AUTHORIZING THE EXECUTION OF CONTRACT MODIFICATIONS WITH THE TEXAS WORKFORCE COMMISSION (TWC) THROUGH AWD WHICH PLEDGES CERTIFICATION OF ADDITIONAL LOCAL EXPENDITURES IN THE AMOUNT OF \$75,431.00 TO USE AS A MATCH TO GENERATE ADDITIONAL FEDERAL FUNDS IN THE AMOUNT OF \$113,951.00 IN THE CCDS PROGRAM; AUTHORIZING CERTIFICATION OF SAID EXPENDITURES IN CONNECTION THEREWITH; AUTHORIZING THE ACCEPTANCE OF SAID ADDITIONAL FEDERAL FUNDS IN THE AMOUNT OF \$113,951.00 FOR THE PROVISION OF CHILD CARE SERVICES; AND ADOPTING A REVISED CCDS PROGRAM BUDGET FOR FISCAL YEAR 2003.

**WHEREAS**, on September 27, 2001, pursuant to Ordinance No. 94646, the City Council authorized the continued operation of the Alamo Child Care Delivery System (CCDS) program from September 1, 2001 to August 31, 2003 with funds from the Texas Workforce Commission (TWC) awarded and managed through Alamo Workforce Development Incorporated (AWD); and

**WHEREAS**, the City of San Antonio, through its Children's Resources Division of the Department of Community Initiatives serves as the administrator for the CCDS Program for the Alamo Workforce Development Area; and

**WHEREAS**, AWD has reviewed their current and prior year child care appropriations to identify any remaining funds for reallocation prior to their expiration; and

**WHEREAS**, AWD has issued a contract modification that provides additional funding in the amount of \$931,000.00 for the provision of child care services in the Alamo Child Care Delivery System (CCDS) Program; and

**WHEREAS**, through the certification of local expenditures in the amount of \$75,431.00, additional funds from TWC through AWD in the amount of \$113,951.00 have been awarded for the provision of child care services; and

**WHEREAS**, it is now necessary to acknowledge a contract modification from AWD, accept additional funds in the amount of \$931,000.00, authorize the execution of a contract modification which pledges certification of local expenditures, authorize certification of said expenditures, authorize acceptance of awarded additional federal match funds in the amount of \$113,951.00 in connection therewith, and authorize the adoption of a revised Child Care Delivery System (CCDS) program budget for fiscal year 2003, **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** Unilateral modification #29 with the Alamo Workforce Development, Inc. (AWD) for the continued operation of the Alamo Child Care Delivery System (CCDS) Program is hereby acknowledged

and accepted. A copy of the contract modification is attached hereto and incorporated herein as Attachment I.

**SECTION 2.** The City Manager, or her designee, are authorized to accept additional funds in the amount of \$931,000.00 from the AWD for the provision of child care services in connection with the Alamo Child Care Delivery System (CCDS) Program for the period September 1, 2002 through August 31, 2003.

**SECTION 3.** The City Manager or her designee, is authorized to execute a contract modification with the Texas Workforce Commission (TWC) through AWD, which pledges the certification of additional local expenditures in the amount of \$75,431.00 to use as matching funds to generate an additional \$113,951.00 in federal match funds in the CCDS program. A copy of the contract modification is attached hereto and incorporated herein for all purposes as Attachment II.

**SECTION 4.** The City Manager or her designee, or the Director of the Department of Community Initiatives, are authorized to certify the expenditures with TWC through AWD as described in Section 3 of this ordinance.


**SECTION 5.** The City Manager or her designee, are authorized to accept an additional \$113,951.00 in federal match funds for the provision of child care services and operations for the period of October 1, 2001 to August 31, 2003.


**SECTION 6.** The revised budget for Project No. 26-039013 entitled "Child Care Delivery System 2002-2003", attached hereto and incorporated herein for all purposes as Attachment III, is hereby adopted.


**SECTION 7.** The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this ordinance.

**SECTION 8.** This ordinance shall be effective on and after the tenth (10<sup>th</sup>) day after passage hereof.
