

AN ORDINANCE **97674**

**AUTHORIZING THE TRANSFER OF \$2,355.91 FROM 1999 G.O. STREET IMPROVEMENT BOND FUNDS TO THE CITY OF SAN ANTONIO PUBLIC WORKS DEPARTMENT; ESTABLISHING A FORCE ACCOUNT; AND AUTHORIZING THE CITY OF SAN ANTONIO PUBLIC WORKS DEPARTMENT TO PROVIDE CONSTRUCTION SERVICES IN CONNECTION WITH THE SOUTHCROSS FROM NEW BRAUNFELS TO S. PRESA (MPO) PROJECT, LOCATED IN COUNCIL DISTRICT 3.**

**WHEREAS**, the Southcross from New Braunfels to S. Presa Project provides for the reconstruction of existing 4-lane roadway to 4 lanes with curbs, 5-foot sidewalks at the curb, driveway approaches, underground storm drainage, and signal upgrades; and

**WHEREAS**, it is necessary to provide for the construction of a driveway at 113 Stratford by City forces, due to the elimination of a driveway at said address, accessing Southcross, due to safety concerns; and

**WHEREAS**, City forces will provide said construction services to install a new driveway; and

**WHEREAS**, approval of this Ordinance will be a continuation of City Council policy to complete previously approved 1999 general Obligation Street Improvement Bond funded Capital Improvement Projects; **NOW THEREFORE**,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The budget in fund 45-972095, 1999 Street Improvements, Sold in 2001, is revised by reducing index code 695577, entitled Unallocated Appropriations: Proceeds, by the amount of \$2,355.91.

**SECTION 2.** The amount of \$2,355.91 is appropriated in fund 45-972037, 1999 Street Improvements, Sold in 2001, in index code 937953, entitled Transfer to 45-979257 Southcross. The amount of \$2,355.91 is authorized to be transferred from fund 45-972037 to fund 45-979257.

**SECTION 3.** The budget in fund 45-979000, 1999 Street Improvements, shall be revised by increasing index code 133652, entitled Trf Fr 45-972037 (45-979257) Southcross, by the amount of \$2,355.91.

**SECTION 4.** The amount of \$2,355.91 is appropriated in fund 45-979257, 1999 Street Improvements, in index code 759795, entitled Construction-City Forces, and is authorized to be encumbered and made payable to City Forces for construction in connection with the Southcross from New Braunfels to S. Presa project.

**SECTION 5.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 6** This Ordinance shall become effective on the 8<sup>th</sup> day of June, 2003.




