

AN ORDINANCE **97060**

**AUTHORIZING THE EXECUTION OF A CONTRACT WITH DRESS FOR SUCCESS SAN ANTONIO (DFSAA) FOR GENERAL OPERATING SUPPORT; AND AUTHORIZING THE ALLOCATION AND EXPENDITURE OF \$1,000.00 FROM THE DISTRICT 6 HUMAN DEVELOPMENT SERVICES FUND, \$1,000.00 FROM THE DISTRICT 1 HUMAN DEVELOPMENT SERVICES FUND, \$500.00 FROM THE DISTRICT 4 HUMAN DEVELOPMENT SERVICES FUND, \$200.00 FROM THE DISTRICT 8 HUMAN DEVELOPMENT SERVICES FUND, AND \$500.00 FROM THE MAYOR'S CONTINGENCY FUND, IN CONNECTION THEREWITH; AS REQUESTED BY COUNCILMAN ENRIQUE M. BARRERA.**

**WHEREAS**, the Fiscal Year (FY) 2002 Adopted Budget established the City Council Human Development Services Fund to support human development service-related purposes; and

**WHEREAS**, the Dress for Success San Antonio (DFSSA) provides suits, job skills, and confidence boosts to woman making a transition from welfare to work; and

**WHEREAS**, on December 9, 2002, Councilmember Enrique Barrera distributed a six-signature memorandum requesting to place as a City Council Agenda item the authorization to use Human Development Services Funds from District 6 in the amount of \$1,000.00 to pay DFSSA's general operational expenditures; and

**WHEREAS**, Councilman Barrera also requested that other Councilmembers consider contributing Human Development Services Funds to support the expenditures the general operational expenditures of the DFSSA; and

**WHEREAS**, the Councilmembers desire to contribute human development and contingency funds totaling \$3,200.00 for said operational expenditures; and

**WHEREAS**, the public purpose for this expenditure is to provide educational training for the community and to prepare the workforce for productive employment; and

**WHEREAS**, it is now the desire of the City Council to authorize the execution of a contract with the DFSSA in the amount of \$3,200.00 to pay for the general operational expenditures of the DFSSA;  
**NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**


**SECTION 1.** The City Manager, or her designee, is authorized to execute a contract with the Dress for Success San Antonio (DFSSA) in the amount of \$3,200.00 to pay for the general operational expenditures of the DFSSA. A copy of said contract is attached hereto and incorporated herein for all purposes as Attachment I.

**SECTION 2.** Funds in the amount of \$3,200.00 are authorized to be encumbered in Fund 11-000000 (General Fund) in the Index Codes specified below and are made payable to Dress For Success San Antonio (DFSAA).
