

AN ORDINANCE     **9 7 0 6 3**

**AUTHORIZING THE EXPENDITURE OF \$78.52 FROM THE DISTRICT 8 CONTINGENCY ACCOUNT FUND, PAYABLE TO THE PARKS AND RECREATION DEPARTMENT, TO BE USED TO OFFSET THE COSTS ASSOCIATED WITH THE DISTRICT 8 “OUR PART OF TOWN TALENT SHOW” HELD AT STINSON MIDDLE SCHOOL; AS REQUESTED BY COUNCILMAN BONNIE J. CONNER, DISTRICT 8.**

**WHEREAS**, Councilwoman Bonnie J. Conner, District 8 has requested Council concurrence for the expenditure of \$78.52 from the Council District 8 Contingency Fund to the Parks and Recreation Department to offset the costs associated with the District 8 “Our Part of Town Talent Show” held at Stinson Middle School; and

**WHEREAS**, the City Council wishes to authorize the expenditure requested by Councilwoman Bonnie J. Conner; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The request of Councilwoman Bonnie J. Conner, District 8, for reimbursement from the Council District 8 Contingency Fund in the amount of \$78.52 to the Parks and Recreation Department to offset the costs associated with the District 8 “Our Part of Town Talent Show” is hereby approved and authorized. A copy of Councilwoman Bonnie J. Conner’s request is set out in **Attachment I**.

**SECTION 2.** The City Manager, or her designee, is hereby authorized to execute an agreement with the Northside I.S.D. in the amount of \$78.52. A copy of the “Agreement to Use Funds of the City of San Antonio,” in substantially final form, is attached hereto as **Attachment II**.


**SECTION 3.** The budget in Fund 11-000 (General Fund) IC 445767 entitled "Fees to Professional Contractors" is authorized to be increased in the amount of \$300 and funds are authorized to be encumbered and payable to Northside I.S.D. to support the "Our Part of Town Talent Show" held at Stinson Middle School.


**SECTION 4.** The budget in IC 603571 entitled District 5 Contingency Funds is authorized to be reduced in support of the "Our Part of Town Talent Show" held at Stinson Middle School.

**SECTION 5.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific index codes and fund numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 6.** This Ordinance shall become effective on the tenth day after the passage hereof.
