

AN ORDINANCE **97053**

ADOPTING REVISIONS TO THE EXISTING CITY OF SAN ANTONIO COMMUNITY DEVELOPMENT HOUSING PROGRAM POLICY GUIDE FOR UTILIZATION IN CONNECTION WITH THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) AND HOME INVESTMENT PARTNERSHIP (HOME) PROGRAMS ADMINISTERED BY THE CITY'S HOUSING AND COMMUNITY DEVELOPMENT DEPARTMENT.

WHEREAS, the City of San Antonio is committed to preserving the existing housing stock and to providing increased housing opportunities affordable to lower income residents; and

WHEREAS, the Community Development Block Grant (CDBG) and Home Investment Partnership Program (HOME) are major sources of funding for the City's housing and revitalization initiatives; and

WHEREAS, inasmuch as each of the above programs is federally funded and thus subject to applicable federal regulations and guidelines, the City may tailor programs to meet the City's housing and revitalization objectives; and

WHEREAS, City Council passed Ordinance No. 70484 on November 2, 1989 to adopt the Community Development Program Policy Guide, wherein CDBG and HOME program requirements, criteria and implementation policies were consolidated into a single resource to facilitate general awareness of its contents; and

WHEREAS, said Community Development Program Policy Guide for CDBG and HOME funds has not been comprehensively updated since its creation; and

WHEREAS, in the interim, City Council has approved CRAG 2000, Housing Services Delivery, the Housing Master Plan and the Housing Reorganization as policy initiatives related to housing; and

WHEREAS, it is the desire of City Council to adopt revisions to the existing Community Development Program Policy Guide to capture many elements of the above policy initiatives related to housing, and to maximize efficient use of CDBG and HOME funds; **NOW THEREFORE:**

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The revisions to the City of San Antonio Community Development Housing Program Policy Guide, a copy of which is attached hereto and incorporated herein by reference as Attachment I, is hereby adopted, and its utilization in conjunction with CRAG 2000, Housing

Services Delivery, the Housing Master Plan, the Community Development Block Grant (CDBG) Program and the Home Investment Partnership Program (HOME) administered by the City's Department of Housing and Community Development, is hereby approved.


SECTION 2. This resolution shall be effective on and after the tenth (10th) day after passage hereof.


