

AN ORDINANCE **97058**

AUTHORIZING THE EXPENDITURE OF \$1,250.00 FROM THE DISTRICT 4 CONTINGENCY ACCOUNT FUND, PAYABLE TO JOY CONCESSIONS FOR PROVIDING A STAGE (\$500.00) AND A LIGHT AND SOUND SYSTEM (\$750.00) FOR THE HERITAGE NEIGHBORHOOD ASSOCIATION'S CHRISTMAS CELEBRATION THAT WAS HELD ON DECEMBER 20, 2002 AT CODY ELEMENTARY SCHOOL; AS REQUESTED BY COUNCILMAN ENRIQUE MARTIN.

WHEREAS, Councilman Enrique Martin, District 4, has requested Council concurrence for the expenditure of \$1,250.00 from the Council District 4 Contingency Fund for providing a stage, light and sound system for the Heritage Neighborhood Association's Christmas celebration that was held on December 20, 2002 at Cody Elementary School; and

WHEREAS, the City Council wishes to authorize the expenditure as requested by Councilman Enrique Martin, **NOW THEREFORE**;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The request of Councilman Enrique Martin, District 4, for payment from the District 4 Contingency Budget Account in the total amount of \$1,250.00 to Joy Concessions, for the purpose set out above is hereby approved and authorized. A copy of Councilman Martin's request is set out in Attachment I.

SECTION 2. The amount of \$1,250.00 is encumbered for payment in the District 4 Contingency Budget Account, Index Code 603555 entitled "District 4 Contingency Fund," and is made payable to Joy Concessions.


SECTION 3. The City Manager, or her designee, is hereby authorized to execute an agreement with the Joy Concessions in the amount of \$1,250.00 for providing a stage, light and sound system for the Heritage Neighborhood Association's Christmas celebration. A copy of the "Agreement to Use Funds of the City of San Antonio" is attached hereto and appearing in substantially the same form as Attachment II.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific index codes and fund numbers as necessary to carry out the purpose of this Ordinance.

SECTION 5. This ordinance shall become effective on the tenth (10th) day after the passage hereof.


