

AN ORDINANCE **98297**

AUTHORIZING THE ACCEPTANCE OF \$186,180.00 FOR SUPPORT OF THE SAN ANTONIO EDUCATION PARTNERSHIP FROM THE FOLLOWING INDEPENDENT SCHOOL DISTRICTS: SAN ANTONIO, EDGEWOOD, HARLANDALE, SOUTH SAN, SOUTH SIDE, SOUTHWEST, AND NORTHEAST; ESTABLISHING A BUDGET; APPROVING A PERSONNEL COMPLEMENT, AND AUTHORIZING THE TRANSFER AND EXPENDITURE OF ANY REMAINING FUNDS FROM PREVIOUS PROGRAM YEARS IN SUPPORT OF THE CURRENT FISCAL YEAR OPERATIONS.

WHEREAS, since 1988, the San Antonio Education Partnership, (SAEP), with support from the City of San Antonio, has provided at-risk students the opportunity to earn scholarships to local colleges and universities in exchange for earning an 80 grade average and 95% attendance at graduation; and

WHEREAS, SAEP provides said services at fifteen (15) area high schools, in seven Independent School Districts; and

WHEREAS, the seven Independent School Districts have made an annual contribution totalling \$186,180.00 to enhance SAEP's program services; and

WHEREAS, it is now necessary for the City to accept such funding so that it may be used to support services provided at participating high schools; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or her designee, is authorized to accept funds to support operations of the San Antonio Education Partnership from the following Independent School Districts (ISD) in the amounts listed below:

Edgewood ISD	24,824.00
Harlandale ISD	24,824.00
South San ISD	12,412.00
Southwest ISD	12,412.00
Southside ISD	12,412.00
Northeast ISD	12,412.00
TOTAL	\$186,180.00

SECTION 2. Fund No 26-012248 entitled: "San Antonio Education Partnership 2002/2003 School District Commitments" is authorized to be established and designated for use in accounting for the above grant. The sum of \$186,180.00 is appropriated in said fund as set out in the budget affixed hereto and incorporated herein for all purposes as Attachment I.

SECTION 3. The personnel complement set out in Attachment II is authorized and approved for this project.

SECTION 4. The budget for the San Antonio Education Partnership is authorized to be modified based upon funds carried forward from previous program years.


SECTION 5. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 6. This ordinance shall be effective on and after the tenth (10th) day after passage hereof.


