

AN ORDINANCE **97970**

**AUTHORIZING THE EXPENDITURE OF \$200.00 FROM THE DISTRICT 2 CONTINGENCY ACCOUNT FUND, PAYABLE TO THE JEFFERSON HEIGHTS NEIGHBORHOOD ASSOCIATION, TO BE USED TO OFFSET THE COSTS ASSOCIATED WITH THE NEIGHBORHOOD NATIONAL NIGHT OUT EVENT WHICH WILL BE HELD ON AUGUST 5, 2003, AS REQUESTED BY COUNCILMAN JOEL WILLIAMS.**

**WHEREAS**, Councilman Joel Williams has requested Council concurrence for the expenditure of \$200.00 from the District 2 Contingency Account Fund to the Jefferson Heights Neighborhood Association to be used to help defray the costs associated with the National Night Out that will be held on August 5, 2003; and

**WHEREAS**, the City Council wishes to authorize the expenditure as requested by Councilman Joel Williams, **NOW THEREFORE**;

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The request of Councilman Joel Williams, City Councilman of District 2, for reimbursement from the District 2 Contingency Budget Account in the amount of \$200.00 to the Jefferson Heights Neighborhood Association, to be used to help offset the cost associated with the National Night Out event that was held on August 5, 2003 is hereby approved and authorized. A copy of Councilman Williams' request is set out in Attachment I hereof.

**SECTION 2.** The amount of \$200.00 is encumbered for payment in the District 2 Contingency Budget Account, Index Code 603431 entitled "District 2 Contingency Fund," and is made payable to the Jefferson Heights Neighborhood Association.

**SECTION 3.** The City Manager, or her designee, is hereby authorized to execute a contract with the Jefferson Heights Neighborhood Association for use of the amount of \$200.00. A copy of the "Agreement to Use Funds of the City of San Antonio" is attached hereto and appearing in substantially the same form as Attachment II.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific index codes and fund numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 5.** This ordinance shall become effective on the tenth (10<sup>th</sup>) day after the passage hereof.
