

AN ORDINANCE **97918**

**AUTHORIZING PAYMENT IN THE AMOUNT OF \$1,939.53 TO DAVIDSON & TROILO, P.C., FOR LEGAL SERVICES IN CONNECTION WITH THE BABCOCK ROAD/LEON CREEK IMPROVEMENTS – HAUSMAN TO DEZAVALA PROJECT (\$75.20), AND THE BITTERS ROAD – WEST AVENUE TO HEIMER MPO PROJECT (\$1,864.33), LOCATED IN COUNCIL DISTRICTS 8 AND 9, RESPECTIVELY; REVISING THE BUDGET; APPROPRIATING FUNDS; AND PROVIDING FOR PAYMENT.**

**WHEREAS**, legal services were required for the Babcock Road/Leon Creek Improvements Project, and the Bitters Road – West Avenue to Heimer (MPO) Project; and

**WHEREAS**, charges for such services are reasonable and necessary expenses relating to the above-mentioned projects; **NOW THEREFORE**;

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The total amount of \$1,939.53 is hereby authorized to be encumbered from the financial adjustments stated below and made payable to **DAVIDSON & TROILO, P.C., 7550 West IH-10, Suite 800, San Antonio, Texas, 78229-5815** for the Projects indicated.

- (a) The budget in Fund No. 45-460095, 1994 Drainage Bonds – Sold in 2000, shall be revised by reducing Index Code 561258, entitled “Unallocated Appropriations-Proceeds”, in the amount of \$75.20.

The budget in Fund No. 45-460013, 1994 Drainage Bonds – Sold in 2000, shall be revised by increasing Index Code 930693, entitled “Transfer to 45-746013 Babcock-DeZavala Hausman”, in the amount of \$75.20. The amount of \$75.20 is authorized to be transferred from Fund 45-460013 to Fund 45-746013.

The budget in Fund No. 45-746000, 1987 Drainage, Sold 1994, shall be revised by increasing Index Code 103762, entitled “Transfer From 45-460013 (45-746013) Babcock”, in the amount of \$75.20.

The amount of \$75.20 is appropriated in Fund No. 45-746013, 1987 Drainage Sold 1994, in Index Code 632273, entitled “Legal Fees”, in connection with the Babcock Road Improvements – DeZavala to Hausman Rd. Project, **Parcels 14566, 14566A, and 14587.**

- (b) The budget in Fund No. 43-070095, Certificates of Obligation 2000A MPO, shall be revised by reducing index code 509315, entitled “Unallocated Appropriations-Proceeds”, by the amount of \$1,864.33.

The amount of \$1,864.33 is appropriated in Fund No. 43-070004, Certificates of Obligation 2000A MPO , in Index Code 617365, entitled "Legal Fees", in connection with the Bitters Road-West Avenue to Heimer (MPO) Project, **Parcels 16449 and 16451.**

**SECTION 2.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.


**SECTION 3.** This ordinance shall take effect on the 17th day of August 2003.
