

AN ORDINANCE **97985**

AUTHORIZING THE ACCEPTANCE OF A CASH AWARD IN THE AMOUNT OF \$75,000.00 FROM BEXAR COUNTY TO FUND THE RYAN WHITE TITLE I HEALTH EDUCATION/RISK REDUCTION (HERR) PROGRAM OF THE SAN ANTONIO METROPOLITAN HEALTH DISTRICT (SAMHD) FOR THE PERIOD JANUARY 1, 2003 THROUGH FEBRUARY 28, 2003; AUTHORIZING THE EXECUTION OF THE RYAN WHITE CARE ACT OF 1990 TITLE I PROGRAM HIV SERVICES MANAGEMENT AGREEMENT WITH BEXAR COUNTY; ESTABLISHING A FUND; ADOPTING A BUDGET; APPROVING THE PERSONNEL COMPLEMENT; AND AUTHORIZING PAYMENTS FOR CONTRACTUAL SERVICES.

**WHEREAS**, the County, through its County Judge, has been awarded grant funds from the U.S. Department of Health and Human Services (USDHHS) to provide HIV/AIDS support services to persons affected by HIV and AIDS, and their families, under Title I of the Ryan White Comprehensive AIDS Resources Emergency Act of 1990; and

**WHEREAS**, the County has offered a contract to the City in the amount of \$75,000.00 for the Ryan White Title I Health Education/Risk Reduction (HERR) Program of the San Antonio Metropolitan Health District (SAMHD) to provide HIV/AIDS support services in San Antonio and the surrounding region for the period January 1, 2003 through February 28, 2003; and

**WHEREAS**, the County and the City believe it to be in the best public interest to provide such assistance for activities under HIV Services Program Management; and

**WHEREAS**, it is now necessary to authorize the acceptance of the cash grant award from Bexar County, approve the execution of the HIV Services Program Management Agreement, establish a fund, adopt a budget, approve a personnel complement, and authorize payments for contractual services; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager, or her designee, is hereby authorized to accept a cash award in the amount of \$75,000.00 from Bexar County to fund the Ryan White Title I Health Education/Risk Reduction (HERR) Program of the San Antonio Metropolitan Health District for the period January 1, 2003 through February 28, 2003. The City Manager, or her designee, is hereby authorized to execute the HIV Services Program Management Agreement with Bexar County. A copy of the HIV Services Program Management Agreement is set out in Attachment II and incorporated herein for all purposes.

**SECTION 2.** The account entitled "Ryan White Title I HIV Services Project 2002/2003", Fund No. 26-063010 has previously been designated for use in the accounting for this Project.

**SECTION 3.** The sum of \$75,000.00 is hereby appropriated in the above-designated fund and the budget set out in Attachment I is approved and adopted for entry on the City books.

**SECTION 4.** The one (1) personnel position set out in Attachment I is hereby authorized for the activity thereon.

**SECTION 5.** Payments in an aggregate amount not to exceed \$20,000.00 are hereby authorized to HEB for gift certificates, in twenty dollar (\$20.00) denominations, to be used as program incentives. These payments will be made from Fund 26-063010, Activity 36-07-89, Index Code 312330.


**SECTION 6.** The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific index codes and fund numbers as necessary to carry out the purpose of this ordinance.


**SECTION 7.** Should the grant awarded be in an amount other than that budgeted for, or should the grant contain terms and conditions different than those currently existing, acceptance of the grant, budget and corresponding personnel complement will be subject to subsequent City Council ordinance.

**SECTION 8.** This ordinance shall be effective on and after the tenth day after passage hereof.
