

AN ORDINANCE **97929**

AUTHORIZING THE ACCEPTANCE OF A CASH GRANT AWARD OF \$45,000.00 FROM THE TEXAS DEPARTMENT OF HEALTH (TDH) TO FUND THE ONGOING SAN ANTONIO METROPOLITAN HEALTH DISTRICT (SAMHD) CHILDHOOD LEAD POISONING PREVENTION PROGRAM FOR THE PERIOD JULY 1, 2003 THROUGH JUNE 30, 2004; APPROVING THE EXECUTION OF A CONTRACT AMENDMENT WITH TDH IN CONNECTION THEREWITH; REVISING THE BUDGET FOR THE PUBLIC HEALTH STATE SUPPORT PROJECT 2003/2004 ESTABLISHED IN ORDINANCE NO. 97154 PASSED AND APPROVED FEBRUARY 6, 2003; AND APPROVING THE PERSONNEL COMPLEMENT.

WHEREAS, the Texas Department of Health (TDH) provides annual financial assistance to the San Antonio Metropolitan Health District (SAMHD) to supplement the delivery of comprehensive public health services to protect the health of all residents within the jurisdiction of the SAMHD; and

WHEREAS, Ordinance 97154, passed and approved on February 6, 2003 authorized the execution of Contract 7460020708 2004 between SAMHD and TDH, which covered the operation of the Public Health State Support Project 2003/2004 of the SAMHD; and

WHEREAS, the TDH has now offered a cash grant award of \$45,000.00 to fund the ongoing Childhood Lead Poisoning Prevention Program in the SAMHD through Contract Change Notice No. 04 to the above contract for the period July 1, 2003 through June 30, 2004; and

WHEREAS, it is now necessary to authorize the acceptance of the cash grant award from the TDH, approve the execution of the contract change notice, revise the budget of the Public Health State Support Project 2003/2004, and approve the personnel complement; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or her designee, is hereby authorized to accept Contract Change Notice No. 04, Attachment No. 05, to Grant Contract 7460020708 2004, with the Texas Department of Health (TDH), which provides \$45,000.00 in cash to fund the ongoing Childhood Lead Poisoning Prevention Program in the San Antonio Metropolitan Health District (SAMHD) for the period July 1, 2003 through June 30, 2004. The City Manager, or her designee, is further authorized to execute a contract amendment with TDH in connection therewith. A copy of said

amendment (Contract Change Notice No. 04) is set out in Attachment II and incorporated herein for all purposes.

SECTION 2. The account entitled "Public Health State Support Project 2003/2004 - Federal, Fund No. 26-016058 has previously been designated for use in the accounting for this Project. This fund is authorized to be revised in accordance with Contract Change Notice No. 04.

SECTION 3. The sum of \$45,000.00 is hereby appropriated in the above-designated fund and the budget set out in Attachment I is approved and adopted for entry on the City books.

SECTION 4. The one (1) personnel position set out in Attachment I is hereby authorized for the activity thereon.

SECTION 5. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific index codes and fund numbers as necessary to carry out the purpose of this ordinance.


SECTION 6. Should the grant awarded be in an amount other than that budgeted for, or should the grant contain terms and conditions different than those currently existing, acceptance of the grant, budget and corresponding personnel complement will be subject to subsequent City Council ordinance.


SECTION 7. This ordinance shall be effective on and after the tenth (10th) day after passage hereof.
