

AN ORDINANCE **97898**

ACCEPTING THE LOW BIDS SUBMITTED BY TEXAS BUS SALES, INC., ITEM 1, AND HOTSHOT DELIVERY SYSTEMS, INC., ITEM 2, TO PROVIDE THE CITY OF SAN ANTONIO COMMUNITY INITIATIVES DEPARTMENT ELDERLY AND DISABLED SERVICES DIVISION WITH TWO NINE PASSENGER TRANSIT BUSES AND TWO CONCEPT VANS FOR A TOTAL AMOUNT OF \$132,150.00.

WHEREAS, bids were submitted to provide the City of San Antonio Community Initiatives Department Elderly and Disabled Services Division with two nine passenger transit buses and two concept vans; and

WHEREAS, the low bids were submitted by Texas Bus Sales, Inc., item 1, and Hotshot Delivery Systems, Inc., item 2, for a total amount of \$132,150.00; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The low bids submitted by Texas Bus Sales, Inc., item 1, and Hotshot Delivery Systems, Inc., item 2, to provide the City of San Antonio Community Initiatives Department Elderly and Disabled Services Division with two nine passenger transit buses and two concept vans for a total amount of \$132,150.00 are hereby accepted. All other bids will be considered rejected upon the deposit by the successful bidder of all required bonds, performance deposits and insurance certificates or the expiration of sixty days from the effective date hereof, whichever occurs first. Attached hereto and incorporated herein for all purposes as Attachment A are the bids and bid tabulation sheets.

SECTION 2. Funding for this ordinance in the amount of \$132,150.00 will be from Fund No. 28-011066, Index Code 742601, and said amount will be encumbered when Purchasing issues the purchase requisition and payment is hereby authorized to Texas Bus Sales for \$77,700.00 and Hotshot Deliver Systems for \$54,450.00.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.


SECTION 4. This ordinance shall take effect ten days from the date of passage.
