

AN ORDINANCE **97933**

AUTHORIZING THE EXECUTION OF CONTRACT NUMBER 7460020708B 2004 WITH THE TEXAS DEPARTMENT OF HEALTH (TDH) FOR THE PUBLIC HEALTH STATE SUPPORT PROJECT 2003/2004 AND THE ACCEPTANCE OF AN INITIAL CASH GRANT AWARD IN THE AMOUNT OF \$560,410.00 FROM TDH TO SUPPORT THE ONGOING LABORATORY BIOTERRORISM PREPAREDNESS PROGRAM OF THE SAN ANTONIO METROPOLITAN HEALTH DISTRICT DURING THE PERIOD SEPTEMBER 1, 2003 THROUGH AUGUST 31, 2004; ADOPTING THE PROJECT BUDGET; AND APPROVING A PERSONNEL COMPLEMENT.

WHEREAS, the Texas Department of Health (TDH) provides annual financial assistance to the San Antonio Metropolitan Health District (SAMHD) to supplement the delivery of comprehensive public health services to protect the health of all residents within the jurisdiction of the SAMHD; and

WHEREAS, TDH has offered a contract to SAMHD that will provide cash assistance to the SAMHD for the Public Health State Support Project 2003/2004 for the period beginning September 1, 2003; and

WHEREAS, TDH has offered \$560,410.00 in cash to SAMHD in order to support the ongoing Laboratory Bioterrorism Preparedness Program of SAMHD during the period September 1, 2003 through August 31, 2004; and

WHEREAS, it is now necessary to authorize the execution of the contract, acceptance of the grant award for the Laboratory Bioterrorism Preparedness Program, and approval of the program budget and personnel complement; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or her designee, is hereby authorized to accept and execute Contract Number 7460020708B 2004 with the Texas Department of Health (TDH), providing \$560,410.00 in cash for the Public Health State Support Project 2003/2004 of the San Antonio Metropolitan Health District (SAMHD) to support the ongoing Laboratory Bioterrorism Preparedness Program during the period of September 1, 2003 through August 31, 2004. A copy of Contract Number 7460020708B 2004 is set out in Attachment II and incorporated herein for all purposes.

SECTION 2. The account entitled “Public Health State Support Project 2003/2004 - Federal”, Fund No. 26-016058, is hereby designated for use in the accounting for the above project.

SECTION 3. The sum of \$560,410.00 is hereby appropriated in the above-designated fund and the budget set out in Attachment I is approved and adopted for entry on the City books.

SECTION 4. The two (2) personnel positions set out in Attachment I and incorporated herein are authorized for the activity shown thereon.

SECTION 5. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager’s designee, correct allocations to specific index codes and fund numbers as necessary to carry out the purpose of this ordinance.


SECTION 6. Should the contract be in an amount other than that budgeted for, or should the contract contain terms and conditions different than those currently existing, acceptance of the contract, budget and corresponding personnel complement will be subject to subsequent City Council ordinance.

SECTION 7. This ordinance shall be effective on and after the tenth day after passage hereof.
