

AN ORDINANCE **97939**

APPROVING THE PARADE PERMIT AND AUTHORIZING THE TEMPORARY CLOSURE OF CERTAIN STREETS NEAR HEMISFAIR PARK IN CONNECTION WITH THE MS WALK TO BE HELD ON SATURDAY, SEPTEMBER 20, 2003 FROM 7:00 A.M. TO 11:00 A.M.; SPONSORED BY THE MULTIPLE SCLEROSIS SOCIETY.

WHEREAS, the Multiple Sclerosis Society has applied for a parade permit in connection with the MS Walk to be held on Saturday, September 20, 2003, from 7:00 a.m. until 11:00 a.m. and has requested the temporary closure of the following streets to vehicular traffic during said time:

Assemble at Hemisfair Park, exit Hemisfair Park onto Alamo, North on Alamo to Houston, West on Houston to Navarro, North on Navarro to St. Mary's, South on St. Mary's to Houston, west on Houston to Santa Rosa, South on Santa Rosa to the Market Square entrance, West through Market Square to San Saba, South on San Saba to Dolorosa, East on Dolorosa to Market, East on Market to Navarro, North on Navarro to Crockett, East on Crockett to Presa, South on Presa to Nueva, and East on Nueva to Hemisfair Park, disbanding at Hemisfair Park; and

WHEREAS, the request for the temporary closure of these streets has been evaluated and it has been found that no adverse traffic problems would result, and that the request should be granted in accordance with the City's usual practice and procedure for temporary closures; **NOW THEREFORE**;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Council hereby approves the requested parade permit so that the Multiple Sclerosis Society may hold its MS Walk on Saturday, September 20, 2003, from 7:00 a.m. until 11:00 a.m.

SECTION 2. The temporary closure of the following streets to vehicular traffic from 7:00 a.m. until 11:00 a.m. on Saturday, September 20, 2003 is hereby authorized:

Assemble at Hemisfair Park, exit Hemisfair Park onto Alamo, North on Alamo to Houston, West on Houston to Navarro, North on Navarro to to St. Mary's, South on St. Mary's to Houston, west on Houston to Santa Rosa, South on Santa Rosa to the Market Square entrance, West through Market Square to San Saba, South on San Saba to Dolorosa, East on Dolorosa to Market, East on Market to Navarro, North on Navarro to Crockett, East on Crockett to Presa, South on Presa to Nueva, and East on Nueva to Hemisfair Park, disbanding at Hemisfair Park.

SECTION 3. The Multiple Sclerosis Society shall be responsible for a) all insurance requirements, b) obtaining the required street closure fee, and any other fees and license charges, c) posting signs, barricades, and off-duty police officers, as may be required by the City of San

Antonio's Public Works and/or Police departments, to evidence the street closure and to provide for the safety of patrons and the rerouting of traffic, and d) cleaning up after the event is held.

SECTION 4. This ordinance shall take effect on August 17, 2003.




