

AN ORDINANCE **97941**

APPROVING THE PARADE PERMIT AND AUTHORIZING THE TEMPORARY CLOSURE OF CERTAIN STREETS IN THE SEA WORLD AREA IN CONNECTION WITH THE SPLASH TRIATHLON AT SEA WORLD TO BE HELD ON SUNDAY, SEPTEMBER 28, 2003 FROM 7:00 A.M. TO 9:30 A.M.; SPONSORED BY ROGER SOLER'S SPORTS.

WHEREAS, the **Soler's Inc., dba Roger Soler's Sports** has applied for a parade permit to hold the "Splash Triathlon at Sea World" to be held on Sunday, September 28, 2003 beginning at 7:00 a.m. until 9:30 a.m.; and

WHEREAS, in order for this event to take place, it will be necessary to temporarily close portions of certain streets in the Sea world of Texas Area to vehicular traffic, as stated the following route:

Assembly Area: Sea World of Texas

Run Route:Exit Sea World property on W. Military; East on W. Military to N. Ellison; North on Ellison to Wiseman; East on Wiseman to Highway 151; South on Highway 151 to Potranco; West on Potranco to N. Ellison; North on Ellison to W. Military; West on Military to finish inside the Sea World area

Cycling Route: On first time around bicycles will continue North on N. Ellison and Circle same route; when bicycles return they will proceed North on N. Ellison to W. Military, and then West on W. Military to finish; and

WHEREAS, the City Council finds that granting the request will promote the health, safety and welfare of the participants and the public in the vicinity; and

WHEREAS, the request has been evaluated and it has been found that no adverse traffic problems would result, and that the request should be granted in accordance with the City's usual practice and procedure;
NOW THEREFORE;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Council hereby approves the requested parade permit to **Soler's Inc., dba Roger Soler's Sports** so that it may hold the "Splash Triathlon at Sea World" on Sunday, September 28, 2003 beginning at 7:00 a.m. until 9:30 a.m.

SECTION 2. In order to hold the "Splash Triathlon at Sea World" on Sunday, September 28, 2003 beginning at 7:00 a.m. until 9:30 a.m., the temporary closure of portions of the streets listed in the route below to vehicular traffic is hereby authorized:

Assembly Area: Sea World of Texas

Run Route:Exit Sea World property on W. Military; East on W. Military to N. Ellison; North on Ellison to Wiseman; East on Wiseman to Highway 151; South on Highway 151 to Potranco; West on Potranco to N. Ellison; North on Ellison to W. Military; West on Military to finish inside the Sea World area

Cycling Route: On first time around bicycles will continue North on N. Ellison and Circle same route; when bicycles return they will proceed North on N. Ellison to W. Military, and then West on W. Military to finish.

SECTION 3. The City Manager is authorized to further implement this ordinance by taking any additional actions deemed necessary to protect the public.

SECTION 4. Soler's Inc. dba Roger Soler's Sports shall be responsible for the following: 1) all insurance requirements, 2) paying the required street closure permit fee and any other fees and license charges, 3) posting signs, barricades and the use of any off duty or on-duty police officers, as may be required by the City of San Antonio's Public Works and/or Police Departments, 4) to evidence the street closure and to provide for the safety of patrons and the rerouting of traffic, and 5) cleaning the area up after the event is held.

SECTION 5. Soler's Inc. dba Roger Soler's Sports shall assume all risks inherent in this event and shall indemnify and hold harmless the City of San Antonio from any and all costs, damages, injuries, or losses attendant to, or in any way growing out of this special use of the public street right-of-ways.


SECTION 6. This ordinance shall be effective on the 17th day of August 2003.


