RATIFYING SUBMISSION OF A CONTINUATION GRANT APPLICATION AND AUTHORIZING THE ACCEPTANCE OF \$101,500.00 FROM THE TEXAS EDUCATION AGENCY (TEA) TO CONTINUE THE ENGLISH LITERACY – CIVICS EDUCATION PROJECT AT THE MARGARITA HUANTES AND WILLIE VELASQUEZ LEARNING AND LEADERSHIP DEVELOPMENT CENTERS FOR THE PERIOD JULY 1, 2003 THROUGH JUNE 30, 2004; AND APPROVING A BUDGET AND PERSONNEL COMPLEMENT.

**WHEREAS**, the Texas Education Agency (TEA) awarded the Department of Community Initiatives a grant in the amount of \$107,000.00 to implement an English Literacy - Civics Education Project at the Margarita Huantes and the Willie Velasquez Learning and Leadership Development Centers (LLDCs) during FY2001-2002 and \$101,500.00 for FY2002-2003 with an opportunity to renew the grant for a total of three years; and

**WHEREAS**, on August 8, 2003, the Department of Community Initiatives received notification from TEA of the award of a third year grant in the amount of \$101,500.00 for continuation of the English Literacy – Civics Education Project at the same LLDCs; and

**WHEREAS**, it is now necessary to ratify the City’s submission of a grant application and authorize acceptance of said funds for continuation of the English Literacy – Civics Education Project; **NOW THEREFORE**;

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**Section 1.** Submission of a continuation grant application to the Texas Education Agency for the English Literacy – Civics Education Project is hereby ratified.


**Section 2.** The City Manager, or her designee, is hereby authorized to accept the award of \$101,500.00 from the Texas Education Agency for continuation of the English Literacy-Civics Education Project at the Margarita Huantes and the Willie Velasquez Learning and Leadership Development Centers for the period of July 1, 2003 through June 30, 2004. A copy of the award notification letter is attached hereto and incorporated herein for all purposes as Attachment I.

**Section 3.** Fund No. 26-041003, entitled “ENGLISH LITERACY-CIVICS EDUCATION PROJECT 2003-04” is hereby designated for use in accounting for the above grant, and the sum of \$101,500.00 is hereby appropriated in said fund as set out in the detailed budget affixed hereto and incorporated herein for all purposes as Attachment II. The personnel complement set out in Attachment III is hereby authorized and approved.

**Section 4.** The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Index Codes and Fund Numbers as necessary to carry out the purpose of this Ordinance.

**Section 5.** This ordinance shall be effective on and after the tenth (10<sup>th</sup>) day after passage hereof.
