

AN ORDINANCE **98035**

AUTHORIZING THE CITY MANAGER OR HER DESIGNEE TO EXERCISE THE OPTION OF A ONE-YEAR RENEWAL CONTRACT WITH COLE MANAGED VISION IN AN ESTIMATED BUDGETED AMOUNT OF \$426,101.00, TO PROVIDE VISION CARE SERVICES FOR CITY'S EMPLOYEES AND ELIGIBLE DEPENDANTS FOR A TERM BEGINNING JANUARY 1, 2004, AND ENDING DECEMBER 31, 2004.

WHEREAS, Cole Managed Vision has administered the vision care services program for the City of San Antonio since January 1, 2001; and

WHEREAS, the original three-year contract, authorized by Ordinance 92435, passed and approved on August 24, 2000, will expire on December 31, 2003; and

WHEREAS the original contract contained a provision for two (2) one (1)-year renewals; and

WHEREAS, a benefits committee, which reviewed Cole Managed Vision's performance to include network and payment options, customer complaints, and overall customer satisfaction, recommends renewal and extension of the contract; and

WHEREAS, the City of San Antonio wishes to exercise its option to renew and extend the term of said contract for the first one (1)-year renewal period; and

WHEREAS, the City Council wishes to authorize the City Manager or her designee to execute a RENEWAL AND EXTENSION OF THE VISION CARE PROGRAM CONTRACT between the City of San Antonio and Cole Managed Vision for a one (1) year period commencing January 1, 2004, and ending December 31, 2004; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee is hereby authorized to execute a RENEWAL AND EXTENSION OF THE VISION CARE CONTRACT extending for a one (1) year period the term of the contract authorized in Ordinance No. 92435 passed and approved on August 24, 2000 with Cole Managed Vision. A copy of said renewal and extension of the vision care services contract, in substantially correct form, is attached hereto as Exhibit A. Said renewal and extension shall be for a one (1) year period

commencing January 1, 2004 and ending December 31, 2004 unless terminated earlier pursuant to the terms of contract authorized in Ordinance No. 92435 or the terms contained in said renewal.

SECTION 2. The amount of \$426,101.00 is to be appropriated in Fund 75-002, Employee Benefits Insurance Program, Index Code 476945, entitled Vision Care Payments, and is to be made payable to Cole Managed Vision for services beginning January 1, 2004 and ending December 31, 2004.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director, may subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific index codes and fund numbers as necessary to carry out the purpose of this Ordinance.

SECTION 4. This ordinance shall be effective on and after the tenth day after passage hereof.


