

AN ORDINANCE **98098**

**AUTHORIZING PAYMENT IN THE AMOUNT OF \$37,019.33 TO BRACEWELL & PATTERSON, L.L.P., FOR LEGAL SERVICES IN CONNECTION WITH THE BASSE ROAD AND SAN PEDRO INTERSECTION MPO PROJECT (\$56.00), ESCALON STREET #1008 DRAINAGE PROJECT (\$72.00), HI-LIONS DRAINAGE PROJECT #80, PHASES III & V (\$1,548.00), HILDEBRAND AVENUE – I.H. 10 TO BREEDEN MPO PROJECT (\$29,567.60), OCTAVIA DRAINAGE #63, PHASE II, PART I PROJECT (\$1,062.00), SAN PEDRO AVENUE – QUINCY TO ROMANA MPO PROJECT (\$78.00), W. W. WHITE PHASE I – RIGSBY TO LORD ROAD PROJECT (\$225.00), WESTERN AVENUE DRAINAGE #74, IIIA PROJECT (\$3,707.23), AND THE WURZBACH ROAD AT I.H. 10 AND IRONSIDE INTERSECTIONS PROJECT (\$703.50); REVISING THE BUDGET; APPROPRIATING FUNDS; AND PROVIDING FOR PAYMENT.**

**WHEREAS**, legal services were required for the Basse Road and San Pedro Intersection MPO project, Escalon Street #1008 Drainage project, Hi-Lions Drainage Project #80, Phases III & V, Hildebrand Avenue – I.H. 10 to Breedon MPO project, Octavia Drainage #63, Phase II Part I project, San Pedro Avenue – Quincy to Romana MPO project, W.W. White Phase I – Rigsby to Lord Road project, Western Avenue Drainage #74, III A project, and the Wurzbach Road at I.H. 10 and Ironside Intersections project.

**WHEREAS**, charges for such services are reasonable and necessary expenses relating to the above-mentioned projects; **NOW THEREFORE**;

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The total amount of \$37,019.33 is hereby authorized to be encumbered from the financial adjustments stated below and made payable to **BRACEWELL & PATTERSON, L.L.P.**, 711 Louisiana, Suite 2900, Houston, Texas 77002-2781 for the Projects indicated.

- (a) The amount of \$56.00 is appropriated in Fund 43-617011, 1996 Certificates of Obligation Street Improvement - MPO, in Index Code 460097, entitled “Legal Fees”, in connection with the Basse Road and San Pedro Intersection MPO Project **Parcel 3-14213**.
- (b) The budget in Fund 45-460095, 1994 Drainage Bonds – Sold in 2000, shall be revised by reducing Index Code 561258, entitled Unallocated Appropriations-Proceeds, in the amount of \$72.00.

The amount of \$72.00 is appropriated in Fund 45-460008, 1994 Drainage Improvement Bonds-Sold in 2000, in Index Code 488585, entitled "Legal Fees", in connection with the Escalon Street Drainage Project #1008 **Parcel 14815**.

- (c) The amount of \$1,548.00 is appropriated in Fund 45-766021, 1987 Drainage Bonds – Sold in 1996, in Index Code 632174, entitled "Legal Fees", in connection with the Hi-Lions Drainage Project #80, Phase III and V Project **Parcels 11569, 11646, 11660, and 11660TE**.
- (d) The amount of \$29,567.60 is appropriated in Fund 43-617012, 1996 Certificates of Obligation Street Improvements, in Index Code 563528, entitled "Legal Fees", in connection with Hildebrand Avenue – I.H. 10 to Breeden (MPO) Project **Parcels 5-14215, 10-14630, and 13-14633**.
- (e) The amount of \$1,062.00 is appropriated in Fund 45-969014, 1999 Drainage Improvements, Index Code 684381, entitled "Legal Fees", in connection with the Octavia Drainage Project #63, Phase II Part I **Parcels 13565 and 13566**.
- (f) The amount of \$78.00 is appropriated in Fund 43-617008, 1996 Certificates of Obligation Street Improvement – MPO, Index Code 464800, entitled "Legal Fees", in connection with the San Pedro Avenue from Quincy to Romana (MPO) Project, **one Parcel**.
- (g) The budget in Fund 45-460095, 1994 Drainage Bonds – Sold in 2000, shall be revised by reducing Index Code 561258, entitled Unallocated Appropriation-Proceeds, by the amount of \$225.00.

The amount of \$225.00 is appropriated in Fund 45-460003, 1994 Drainage Bonds – Sold in 2000, in Index Code 920173, entitled Transfer to 45-546007, WW White-Rigsby to Lord. The amount of \$225.00 is authorized to be transferred from Fund 45-460003 to Fund 45-546007.

The budget in Fund 45-546000, 1985 Drainage & Flood Control, Sold 1994, shall be revised by increasing Index Code 129650, entitled Transfer From 45-460003(45-546007) W.W. White-Rigsby to Lord, by the amount of \$225.00.

The amount of \$225.00 is appropriated in fund 45-546007, 1985 Drainage & Flood Control, Sold 1994, in Index Code 624965, entitled Legal Fees, in connection with the W.W. White Phase I – Rigsby to Lord Project **Parcel 14793**.

- (h) The amount of \$3,707.23 is appropriated in Fund 45-506454, 1985 General Obligation Drainage & Flood Control Bonds, in Index Code 564187, entitled "Legal Fees", in connection with the Western Avenue Drainage #74, IIIA Project **Parcels 10571, 10572, and 10576**.
- (i) The budget in Fund 43-171095, 2001 Street Improvements, shall be revised by reducing Index Code 695734, entitled Unallocated Appropriations, by the amount of \$703.00.

The amount of \$703.50 is appropriated in Fund 43-171008, 2001 Street Improvements, in Index Code 936633, entitled Transfer to 43-617037 Wurzbach at I.H. 10 and Ironside Intersections MPO. The amount of \$703.50 is authorized to be transferred from Fund 43-171008 to Fund 43-617037.

The budget in Fund 43-617000, 1996 Certificates of Obligation Street Improvement MPO, shall be revised by increasing Index Code 122432, entitled Transfer From 43-171008(43-617037) Wurzbach at I.H. 10, by the amount of \$703.50.

The amount of \$703.50 is appropriated in fund 43-617037, 1996 C of O Street Improvement MPO, in Index Code 648188, entitled Legal Fees, in connection with the Wurzbach at I.H. 10 and Ironside Intersections (MPO) Project **Parcel 4-14504**.

**SECTION 2.** The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Index Code and Fund Numbers as necessary to carry out the purpose of this ordinance.

**SECTION 3.** This Ordinance shall be effective on the tenth day after passage hereof.
